<b>HB 745</b>	<b>FRANKLIN</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the District Thirty-Four Economic Development District in Calcasieu Parish
<b>HB 836</b>	<b>BADON, AUSTIN</b>	<b>DISTRICTS/SPECIAL</b> Creates the New Orleans East Advisory Neighborhood Commission
<b>HB 936</b>	<b>LEGER</b>	<b>LOCAL FINANCE/BUDGET ACT</b> Relative to budgets of local entities, provides for inclusion as expenditures of payment of judgments and settlements and prohibits borrowing for capital expenditures when current expenditures are not timely paid
<b>HB 1094</b>	<b>DIXON</b>	<b>DISTRICTS/TAXING</b> Provides for the creation of a tax increment financing district in the city of Alexandria
<b>HB 1235</b>	<b>LEGER</b>	<b>SEWERAGE/NO WATER BD</b> Provides relative to water service provided by the Sewerage and Water Board of New Orleans
<b>HB 1238</b>	<b>MORRELL</b>	<b>WATER/SEWER OPERATORS</b> Provides relative to water supply systems and sewerage systems
<b>HB 1297</b>	<b>BARROW</b>	<b>HOUSING</b> Authorizes parish and municipal ordinances to secure or condemn and demolish and remove structures that endanger the public health and welfare, including payment of costs, and provides for National Guard assistance
<b>HB 1330</b>	<b>HONEY</b>	<b>DISTRICTS/TAXING</b> Creates the Revitalization Economic Development District in East Baton Rouge Parish
<b>HB 1334</b>	<b>MARCHAND</b>	<b>CEMETERIES</b> Provides for the creation of the Louisiana Historic Cemetery Trust Fund
<b>HB 1343</b>	<b>ELLINGTON</b>	<b>LOCAL AGENCIES</b> Provides relative to long term contracts for the purchase of natural gas by political subdivisions

<b>HCR 42</b>	<b>HARDY</b>	<b>HONORARY DESIGNATIONS</b> Designates the city of Opelousas as the Zydeco Capital of the World
<b>SB 25</b>	<b>DUPRE</b>	<b>SPECIAL DISTRICTS</b> Creates the Terrebonne Parish Veterans' Memorial District. (gov sig)
<b>SB 291</b>	<b>DONAHUE</b>	<b>ECONOMIC DEVELOPMENT</b> Renames the East Florida Parishes Retirement District as La.'s I-12 Retirement District. (7/1/08)
<b>SB 710</b>	<b>SHEPHERD</b>	<b>LOCAL AGENCIES</b> Authorizes the Jefferson Parish Housing Authority to levy a tax with approval of the parish governing authority. (8/15/08)
<b>SB 724</b>	<b>THOMPSON (TBA)</b>	<b>MUSEUMS</b> Provides with respect to the Louisiana State Museum, including membership and appointment of the board of directors and the lease of certain property. (8/15/08) ( <b>Subject to Rule Suspension</b> )
