<b>HB 1092</b>	<b>JONES, SAM</b>	<b>CEMETERIES/HISTORICAL</b> Provides for the creation of the Louisiana Historic Cemetery Preservation Act
<b>HB 1334</b>	<b>MARCHAND</b>	<b>CEMETERIES</b> Provides for the creation of the Louisiana Historic Cemetery Trust Fund
<b>SB 72</b>	<b>CROWE</b>	<b>PUBLIC CONTRACTS</b> Authorizes the city of Slidell to enter into design-build contracts. (8/15/08)
<b>SB 147</b>	<b>MARTINY</b>	<b>MUNICIPALITIES</b> Authorizes the board of aldermen, upon the mayor's request, to appoint one or more magistrates and one or more prosecutors for mayor's court. (gov sig)
<b>SB 156</b>	<b>CRAVINS, JR.</b>	<b>SPECIAL DISTRICTS</b> Provides relative to the St. Landry Parish Economic and Industrial Development District. (8/15/08)
<b>SB 164</b>	<b>THOMPSON</b>	<b>MUSEUMS</b> Changes the name of the Aviation and Military Museum of Louisiana, Inc., to the Chennault Aviation and Military Museum of Louisiana, Inc. (8/15/08)
<b>SB 319</b>	<b>CASSIDY</b>	<b>TAX/LOCAL</b> Establishes an additional procedure for creating neighborhood crime prevention and security districts and levying parcel fees in any parish or municipality. (gov sig)
<b>SB 564</b>	<b>GRAY</b>	<b>SPECIAL DISTRICTS</b> Creates and provides for the Maple Area Residents Security Tax District. (8/15/08)

<b>SB 676</b>	<b>LAFLEUR</b>	<b>PUBLIC BUILDINGS/GROUNDS</b> Designates the visitor center at the Louisiana State Arboretum as the J. D. "Prof" Lafleur Visitors Center. (8/15/08)
<b>SB 681</b>	<b>DUPLESSIS</b>	<b>SPECIAL DISTRICTS</b> Create the New Orleans East Advisory Neighborhood Commission. (8/15/08)
<b>SB 696</b>	<b>ERDEY</b>	<b>SPECIAL DISTRICTS</b> Increases the per diem of the board of commissioners of Livingston Parish Recreation District No. 2. (8/15/08)
<b>SB 724</b>	<b>THOMPSON</b>	<b>MUSEUMS</b> Provides with respect to the Louisiana State Museum, including membership and appointment of the board of directors and the lease of certain property. (8/15/08)
<b>SB 732</b>	<b>GRAY</b>	<b>MUNICIPALITIES</b> Provides for a neighborhood enhancement program to be administered by the Louisiana Department of Culture, Recreation and Tourism. (See Act)
<b>SB 745</b>	<b>GRAY</b>	<b>SPECIAL DISTRICTS</b> Provides relative to the Greater New Orleans Bioscience Economic Development District. (8/15/08)
<b>SB 760</b>	<b>THOMPSON</b>	<b>MUSEUMS</b> Provides for changes to the membership of the Louisiana Civil Rights Museum Advisory Board and the Eddie G. Robinson Museum Commission. (8/15/08)
<b>SB 802</b>	<b>GRAY</b>	<b>STATE AGENCIES</b> Reestablishes the Hurricane Katrina Memorial Commission. (gov sig)
