| HB 215 | HUTTER (TBA) | TAX CREDITS Creates the Ports of Louisiana Investor Tax Credit (Subject to Rule Suspension) |
| HB 614 | MONICA (TBA) | TAX CREDITS Authorizes a motion picture investor tax credit for state-certified infrastructure projects (Subject to Rule Suspension) |
| HB 714 | NORTON | GAMING/REVENUE Provides for a promotional expense deduction under certain conditions from the definition of net gaming proceeds, net slot machine proceeds, and gross revenue |
| SCR 2 | CROWE | CONGRESS Memorializes Congress to affirm Louisiana's sovereignty under the Tenth Amendment of the Constitution of the United States of America and to demand that the federal government halt its practices of assuming powers and imposing mandates upon the states for purposes |

SB 183 APPEL


