<b>HCR 1</b>	<b>FOIL</b>	<b>CONSTITUTION/CONVENTION</b> Creates a commission to study the feasibility of a constitutional convention and to make recommendations relative thereto
<b>HCR 3</b>	<b>PONTI (TBA)</b>	<b>STATE AGENCIES</b> Directs state agencies to maximize efficiency, minimize waste, and save taxpayer dollars ( <b>Subject to Rule Suspension</b> )
<b>HB 49</b>	<b>RICHARD</b>	<b>ETHICS/FINANCIAL DISCLOS</b> Provides relative to financial disclosure by elected officials representing voting districts of fewer than 5,000
<b>HB 194</b>	<b>DIXON</b>	<b>VOTING/REGISTRATION</b> Provides relative to the close of registration records in a parish in which the registrar is unable to open at least one office on the final day for registration
<b>HB 202</b>	<b>RICHARDSON</b>	<b>CRIMINAL/VICTIMS</b> Provides for the confidentiality of crime victims
<b>HB 243</b>	<b>ABRAMSON</b>	<b>ETHICS</b> Requires disclosure by certain officials of information relative to employment and appointment of campaign contributors
<b>HB 311</b>	<b>WHITE</b>	<b>PUBLIC RECORDS</b> Provides for an exemption from public records for certain internal affairs records of law enforcement agencies
<b>HB 470</b>	<b>ABRAMSON</b>	<b>CONSTITUTION/CONVENTION</b> Provides relative to a constitutional convention
<b>HB 508</b>	<b>GREENE</b>	<b>PUBLIC OFFICIALS</b> Requires annual performance evaluations for certain public officials
<b>HB 724</b>	<b>JACKSON, G.</b>	<b>COURTS/DISTRICT</b> Provides for districts and election sections for the Juvenile Court of the parish of Jefferson
<b>HB 762</b>	<b>GREENE</b>	<b>PUBLIC RECORDS</b> Provides relative to public records
<b>HB 773</b>	<b>BURFORD</b>	<b>PHYSICAL THERAPISTS</b> Provides for the revision and restatement of the Physical Therapy Practice Act of Louisiana

**ELECTIONS/CONGRESSIONAL** Provides relative to conduct of congressional elections and particularly congressional party primary elections

**HB 806 KATZ**

**BOARDS/COMMISSIONS** Provides relative to fees and background checks by the Board of Nursing Facility Administrators

**HB 826 GALLOT**

**ETHICS** Provides for the organization of and assignment of functions and duties to the staff of the Board of Ethics
