HB 1328	HARDY	<b>INSURANCE</b> Requires that the owner of dangerous dog shall maintain liability insurance to redress any personal injury inflicted by the animal
HB 1360	WOOTON	<b>FRAUD</b> Amends provisions of law regarding insurance fraud
SB 664	HEBERT	<b>HEALTH/ACC INSURANCE</b> Require medical necessity review organizations to notify the commissioner of insurance upon changes in fact or circumstance affecting its qualification for a license. (8/15/10)
SB 665	HEBERT	<b>INSURERS</b> Repeals the requirement of filing policies and applications by foreign and alien insurers when applying for a certificate of authority. (8/15/10)
