<b>HB 446</b>	<b>ROY</b>	<b>INSURANCE/POLICIES</b> Repeals provisions defining and otherwise providing with respect to certificates of insurance
<b>HB 1182</b>	<b>GREENE</b>	<b>INSURANCE/HEALTH-ACCID</b> Requires network adequacy of health insurance issuers
<b>SB 120</b>	<b>MARTINY</b>	<b>INSURANCE PREMIUMS</b> Increases the minimum premium rate on criminal bail bonds. (8/15/10)
<b>SB 135</b>	<b>DUPLESSIS</b>	<b>INSURERS</b> Require insurance carriers to provide utilization data within fourteen business days after a written request is received. (8/15/10).
<b>SB 150</b>	<b>DUPLESSIS</b>	<b>INSURANCE RATES</b> Provides relative to automobile insurance rates after a voluntary lapse in coverage occurs. (8/15/10)
<b>SB 153</b>	<b>ERDEY</b>	<b>HEALTH/ACC INSURANCE</b> Relative to the high risk health insurance pool. (gov sig)
<b>SB 246</b>	<b>MCPHERSON</b>	<b>INSURANCE POLICIES</b> Prohibits certain assessments of a monetary penalty by an insurer against an insured as a result of the insured's cancellation of a policy prior to the expiration of the policy. (8/15/10)
<b>SB 268</b>	<b>LAFLEUR</b>	<b>INSURERS</b> Provides for the creation of the Louisiana Insurance Guaranty Association Law. (gov sig)
<b>SB 663</b>	<b>HEBERT</b>	<b>AUTOMOBILE INSURANCE</b> Provides for minimum collision coverage amounts of uninsured motorist insurance. (8/15/10)
<b>SB 673</b>	<b>HEBERT</b>	<b>INSURANCE COMMISSIONER</b> Provide for the filing of annual audited financial statements by certain public trust funds. (8/15/10)
<b>SB 674</b>	<b>HEBERT</b>	<b>PROPERTY INSURANCE</b> Provide for the annual filing of actuarial opinions by property and casualty insurance companies. (8/15/10)

<b>SB 675</b>	<b>HEBERT</b>	<b>INSURERS</b> Provide for the retention of original records of domestic insurers. (8/15/10)
<b>SB 677</b>	<b>HEBERT</b>	<b>INSURERS</b> Provide for investments of domestic insurers. (8/15/10)
<b>SB 683</b>	<b>LAFLEUR (TBA)</b>	<b>HEALTH/ACC INSURANCE</b> Requires health insurance issuers to directly pay noncontracted health care providers of emergency services for their charges as determined pursuant to the plan or policy of enrollee and insurer. (8/15/10) <b>(Subject to rules suspension)</b>
