

| <b>HCR 6</b>  | <b>BISHOP, STUART</b> | <b>WILDLIFE &amp; FISHERIES</b> Specifies accreditation requirements for exemption from Wildlife and Fisheries Commission rules governing possession of exotic cats   |
| <b>HCR 10</b> | <b>REYNOLDS</b>       | <b>FISHING</b> Memorializes congress to encourage the National Marine Fisheries Service, the Gulf of Mexico Marine Fisheries Council, and the Gulf of Mexico Fisheries Management Council to adopt a weekend only fishery for red snapper |
| <b>HCR 49</b> | <b>ORTEGO</b>         | <b>WATERWAYS/SCENIC RIVERS</b> Requests the Dept. of Wildlife and Fisheries to study Bayou Teche for possible inclusion into the Historic and Scenic Rivers program   |
| <b>HB 216</b> | <b>HARRISON</b>       | <b>FISHING/COMMERCIAL</b> Authorizes the Dept. of Wildlife and Fisheries to issue certain commercial fish licenses via the Internet   |
| <b>HB 230</b> | <b>THIBAUT</b>        | <b>HUNTING</b> Provides for weapons used during primitive firearms season   |
| <b>HB 233</b> | <b>BURFORD</b>        | <b>HUNTING</b> Allows night hunting of nuisance animals year-round on private property  |
| <b>HB 401</b> | <b>GISCLAIR</b>       | <b>FISHING/SHRIMP</b> Provides relative to the Wildlife and Fisheries Commission's powers to manage and control the taking of shrimp including bait shrimp  |
| <b>HB 406</b> | <b>GREENE</b>         | <b>FISHING/RECREATIONAL</b> Authorizes the Wildlife and Fisheries Commission to establish recreational reefs where oyster harvest is prohibited   |
| <b>HB 431</b> | <b>GAROFALO</b>       | <b>FISHING/OYSTERS</b> Extends the application period for an oyster seed ground vessel permit   |
| <b>HB 486</b> | <b>BURNS, HENRY</b>   | <b>WILDLIFE &amp; FISHERIES DEP</b> Provides relative to expenditure of the funds received from the sale of Wild La. Stamps   |
| <b>HB 538</b> | <b>HARRISON</b>       | <b>FISHING/CRABS</b> Authorizes the WLF Commission to set crab season   |

<b>HB 557</b>	<b>HENSGENS</b>	<b>HUNTING</b> Authorizes the taking of certain nuisance animals
<b>HB 570</b>	<b>MONTOUCET</b>	<b>HUNTING/ALLIGATORS</b> Requires certain information relative to shipments of alligator parts or skins and exempts from the Public Records Act certain records held by the Dept. of Wildlife and Fisheries relative to specific shipments of alligator parts or skins
<b>HB 643</b>	<b>MONTOUCET</b>	<b>FUNDS/FUNDING</b> Provides relative to the Alligator Resource Fund
<b>HB 651</b>	<b>LAMBERT</b>	<b>FISHING/DEVICES</b> Provides for uniformity for fishing gear authorized to be used on certain freshwater lakes
<b>HB 683</b>	<b>DOVE</b>	<b>FISHING/OYSTERS</b> Provides relative to alternative oyster culture
