HB 497	BARRAS	TAX/AD VALOREM - EXEMPTION (Constitutional Amendment) Authorizes the city of New Iberia to grant contracts for the exemption of property annexed by the city (Technical Review Only)

HB 524	BURNS, TIM (TBA)	BOARDS/COMMISSIONS (Constitutional Amendment) Provides relative to membership of constitutional boards and commissions with members from congressional districts (<i>Technical Review Only</i>) (Subject to Rule Suspension)
HB 609	SEABAUGH (TBA)	SCHOOLS/BOARDS (Constitutional Amendment) Removes geographic limitations on the legislature's authority to create new school boards and on provisions relative to financing education (<i>Technical Review Only</i>) (Subject to Rule Suspension)
HB 674	ROBIDEAUX (TBA)	TAX/AD VALOREM-EXEMPTION (Constitutional Amendment) Authorizes the granting of ad varlorem tax exemption contracts by the Board of Commerce and Industry for certain businesses (<i>Technical Review Only</i>) (Subject to Rule Suspension)
HB 862	LAMBERT	CIVIL/ACTIONS Provides with respect to civil actions for environmental damages
HB 910	JOHNSON	CHILDREN/SUPPORT Provides for child support obligations due to nonparent custodians and other third parties
HB 1077	BISHOP, WESLEY	LIABILITY/CIVIL Provides relative to the La. Governmental Claims Act
HB 1081	BROSSETT	ADOPTION Provides with respect to intrafamily adoptions
HB 1150	HUNTER	CIVIL/PLEADINGS Provides with respect to facsimile filings
HB 1153	HUNTER	FAMILY LAW Mandates child visitation in certain support cases
HB 1158	CONNICK	CIVIL/DISCOVERY Provides with respect to pretrial procedure in civil matters
