<b>HR 72</b>	<b>BURNS, HENRY</b>	<b>MILITARY AFFAIRS</b> Requests the Dept. of Veterans Affairs to study the necessity and feasibility of establishing a Veterans Business Enterprise Program
<b>HR 88</b>	<b>CONNICK</b>	<b>MINERALS/LEASES</b> Requests the attorney general to investigate the validity of mineral lease contracts with the Win or Lose Corporation
<b>HCR 124</b>	<b>DIXON</b>	<b>CRIMINAL/CONVICTIONS</b> Requests the Innocence Project New Orleans to apply to the Judicial Council for an additional court cost to fund the Innocence Compensation Fund
<b>HB 370</b>	<b>HOFFMANN</b>	<b>DISTRICT ATTORNEYS</b> Authorizes a district attorney to convene a multidisciplinary team in cases of prenatal addiction
<b>HB 758</b>	<b>BADON</b>	<b>LAW ENFORCEMENT</b> Authorizes the governor to activate national guard troops to assist local law enforcement in certain municipalities upon reaching a certain homicide rate
<b>HB 1012</b>	<b>LORUSSO</b>	<b>LAW ENFORCE/OFFICERS</b> Provides with respect to release of personal information of law enforcement officers
<b>SCR 72</b>	<b>ERDEY</b>	<b>HOSPITALS</b> Establishes an advisory group to determine the future utilization of the former Greenwell Springs Mental Health Hospital facility.
<b>SB 123</b>	<b>BUFFINGTON</b>	<b>LEGIS POWERS/FUNCTIONS</b> Designates October 25 <sup>th</sup> , 26 <sup>th</sup> , and 27 <sup>th</sup> as "Care Enough to Wear Pink" days in Louisiana. (8/1/12)
<b>SB 204</b>	<b>MORRISH (TBA)</b>	<b>CIVIL PROCEDURE</b> Includes Louisiana Citizens Property Insurance Corporation among the entities exempt from furnishing bonds in judicial proceedings. (8/1/12) <b>(Subject to Rule Suspension)</b>
<b>SB 280</b>	<b>MURRAY</b>	<b>JUDGES</b> Provides relative to the divisions of the Traffic Court of New Orleans and the terms of the judges thereof. (gov sig)

**SB 700**      **BROWN, TROY**

**HOMELAND SECURITY** Requires the parish office of homeland security and emergency preparedness to establish a voluntary registry of persons with special needs. (8/1/12)

**SB 761**      **MORRELL**

**JUVENILES** Requires certain data to be reported. (8/1/12)
