| HB 117 | HOWARD | COURTS/DISTRICT Authorizes the 11 th JDC to provide for a reentry division of court |
| HB 607 | MORENO | COURTS/JUVENILE Provides for the elimination of two judgeships from the Orleans Parish Juvenile Court |
| SCR 6 | CROWE (TBA) | LEGISLATIVE AGENCIES Requests that the Louisiana State Law Institute study the feasibility of requiring clerks of court to accept electronic signatures on documents to be filed with the court. (Subject to Rule Suspension) |
| SB 5 | LAFLEUR (TBA) | JUDGES Constitutional amendment to remove the mandatory retirement age of judges. (2/3 – CA13s1(A)) (Subject to Rule Suspension) |
| SB 46 | DORSEY-COLOMB | CLERKS OF COURT Provides for the payment of group insurance premiums of certain retirees of the clerk of court's office in East Baton Rouge Parish. (8/1/13) |
| SB 66 | AMEDEE | CLERKS OF COURT Provides for the payment of medical insurance premiums of certain retirees of the clerk of court's office in St. James Parish. (8/1/13) |
| SB 94 | NEVERS | CRIMINAL PROCEDURE Provides for the use in the Twenty-Second Judicial District Court of a validated risk/needs assessment tool at the pretrial stage. (8/1/13) |
| SB 107 | WARD | JUVENILE JUSTICE Provides relative to at-risk youths and development of an integrated case management system. (8/1/13) |
| SB 116 | GALLOT | ALCOHOLIC BEVERAGES Authorizes certain municipalities to conduct local option elections regarding the sale of alcohol in restaurants. (gov sig) |
| SB 124 | MURRAY | COURTS Increases certain fees and court costs levied by the Criminal District Court for the Parish of Orleans. (2/3-CA7s2.1) (gov sig) |

- SB 152** **MURRAY** **COURTS** Authorizes courts exercising juvenile jurisdiction to designate by rule one or more divisions to which gun and weapon-related offenses may be assigned and to establish a weapon-related offenses probation program. (gov sig)
- SB 155** **MURRAY** **COURTS** Increases certain filing fees and costs levied by Louisiana Supreme Court. (gov sig) (2/3 - CA7s2.1)
- SB 240** **MURRAY** **COURTS** Authorizes imposition of court cost in Orleans Parish Criminal District Court under certain circumstances to defray operating expenses of clerk. (2/3 - CA7s2.1) (gov sig)
