_____	<b>HCR 58</b>	<b>MONTOUCET</b>	<b>TAX/INCOME TAX</b> Suspends all corporate income tax credits, deductions, exclusions, and exemptions
_____	<b>HB 148</b>	<b>BADON</b>	<b>TAX/TOBACCO TAX</b> Levies an additional tax on cigarettes and tobacco products and dedicates the monies
_____	<b>HB 336</b>	<b>CONNICK</b>	<b>TAX/SALES &amp; USE</b> Provides for the collection of sales and use tax imposed on the purchase of motor vehicles by certain foreign business entities
_____	<b>HB 412</b>	<b>MORRIS, JAY</b>	<b>FUNDS/FUNDING</b> (Constitutional Amendment) Dedicates the avails of the existing one percent state sales and use taxes for the support of public elementary through post-secondary education
_____	<b>HB 474</b>	<b>SMITH, P.</b>	<b>TAX/INCOME TAX</b> Repeals the individual income tax deduction for certain net capital gains
_____	<b>HB 509</b>	<b>SMITH, P.</b>	<b>TAX/SALES &amp; USE</b> Suspends the state sales and use tax exemption for business utilities
_____	<b>HB 563</b>	<b>THIERRY</b>	<b>TAX CREDITS</b> Reduces certain income and corporation franchise tax credits
_____	<b>HB 624</b>	<b>JACKSON</b>	<b>TAX/CORP INCOME</b> Reduces the amount of certain corporate income tax exclusions and deductions

_____	<b>HB 629</b>	<b>JACKSON</b>	<b>TAX CREDITS</b> Reduces income and corporation franchise tax credits
_____	<b>HB 713</b>	<b>LANDRY, T.</b>	<b>TAX CREDITS</b> Reduces certain income and corporate franchise tax credits

_____	<b>HB 777</b>	<b>ST. GERMAIN</b>	<b>TAX/GASOLINE TAX</b> Increases the state excise tax on gasoline, diesel, and special fuels for ten years
_____	<b>HB 778</b>	<b>ST. GERMAIN</b>	<b>TAX/SALES-USE, STATE</b> Imposes a one cent state sales and use tax for ten years dedicated to the construction of highways and bridges constituting major economic development corridors and capitalization of the Louisiana State Transportation Infrastructure Bank
_____	<b>HB 819</b>	<b>BURNS, T.</b>	<b>TAX CREDITS</b> Establishes a maximum threshold for the reduction of tax liability due to the application of certain tax credits
