_____	HB 266	MARCELLE	CIVIL SERVICE Prohibits certain questions regarding criminal history during the employment process for certain positions
_____	HB 308	BACALA	PUBLIC OFFICIALS Prohibits the granting increases in pay for state officials and employees during a certain period of time and provides for personal liability for the aggregate amount of such increases for a period of three years
_____	HB 342	JONES	SCHOOLS/BOARDS (Constitutional Amendment) Authorizes the legislature to pass local laws providing relative to the St. Mary Parish School Board
_____	HB 349	EMERSON	STATE EMPLOYEES Provides with respect to inquiries about criminal background checks in certain public employment situations
_____	HB 369	BISHOP, S.	REAPPORTIONMENT Requires the submission of redistricting plans in a specified format to the secretary of state
_____	HB 414	BISHOP, S.	SECRETARY OF STATE Authorizes the secretary of state to promulgate rules and forms for the registration of individuals who serve as demographers for the development of

reapportionment or redistricting plans in Louisiana

_____	HB 518	BROADWATER	BOARDS/COMMISSIONS Provides relative to information concerning the fitness of a person to be certified by the Board of Examiners of Certified Shorthand Reporters
_____	HB 575	BROADWATER	CONSTITUTION/AMENDMENT (Constitutional Amendment) Provides relative to civil service status of workers' compensation judges
_____	HB 598	SMITH, P.	VOTING/REGISTRATION Provides relative to registration and voting by a person convicted of a felony
_____	HB 746	THIBAUT	INSURANCE Provides for licensing and regulation of insurance consultants by the commissioner of insurance
_____	HB 951	CARTER, G.	VOTING/REGISTRATION Provides for the close of registration records
_____	HB 1079	RICHARD	POLITICAL PARTIES Provides relative to inclusion of political party affiliation on the notice of candidacy and the ballot
_____	HB 1091	IVEY	ELECTIONS Provides for the conduct of federal elections
_____	HCR 33	DANAHAY	ELECTIONS Urges and requests the secretary of state to provide a mechanism to provide all elections division employees within the Department of State who have received CERA certification with a pay increase relative to such certification
_____	HCR 67	JOHNSON, M.	GOVERNMENT ORGANIZATION Requests the Department of State Civil Service to review the span of control of supervisors in state government and to report to specified legislative committees no later than August 15, 2016
_____	HCR 68	DANAHAY	ELECTIONS Directs the secretary of state to establish and maintain a toll-free number to be used by the public to report election issues and problems
