_____	<b>HB 207</b>	<b>BAGNERIS</b>	<b>ELECTIONS</b> Provides for the conduct of early voting on the Sunday during the early voting period from 12:00 p.m. to 5:00 p.m.
_____	<b>HB 230</b>	<b>SMITH, P.</b>	<b>VOTERS/VOTING</b> Provides relative to early voting days interrupted by a holiday
_____	<b>HB 342</b>	<b>JONES</b>	<b>SCHOOLS/BOARDS</b> (Constitutional Amendment) Authorizes the legislature to pass local laws providing relative to the St. Mary Parish School Board
_____	<b>HB 376</b>	<b>DANAHAY</b>	<b>REGISTRARS OF VOTERS</b> Prohibits the registrar, chief deputy registrar, and confidential assistant of the registrar from receiving certain increases in salary under certain circumstances
_____	<b>HB 459</b>	<b>DANAHAY</b>	<b>REGISTRARS OF VOTERS</b> (Constitutional Amendment) Provides that the manner of appointment and qualifications of the registrar are to be provided by law
_____	<b>HB 470</b>	<b>DANAHAY</b>	<b>REGISTRARS OF VOTERS</b> Provides that an appeal of an evaluation of a registrar of voters is conducted by the State Board of Elections Supervisors

_____	<b>HB 583</b>	<b>BROADWATER</b>	<b>ELECTIONS/CANDIDATES</b> Provides relative to withdrawal of candidates
_____	<b>HB 593</b>	<b>DANAHAY</b>	<b>REGISTRARS OF VOTERS</b> Provides relative to the appointment of registrars of voters
_____	<b>HB 599</b>	<b>GAINES</b>	<b>VOTERS/VOTING</b> Provides for automatic voter registration through driver's license facilities
_____	<b>HB 877</b>	<b>HUNTER</b>	<b>VOTERS/VOTING</b> Provides relative to early voting
_____	<b>HB 898</b>	<b>MILLER, G.</b>	<b>CAMPAIGN FINANCE DISCLOS</b> Changes the definition of motor vehicles relative to the prohibition on purchasing motor vehicles with campaign funds to provide that such prohibition does not apply to trailers
