_____	<b>HB 272</b>	<b>BROWN, CHAD</b>	<b>INSURANCE/HEALTH</b> Provides for insurance coverage for acupuncture
_____	<b>HB 295</b>	<b>HILL</b>	<b>COURTS/MAGISTRATES</b> Provides for a magistrate judge in the 14 <sup>th</sup> JDC
_____	<b>HB 387</b>	<b>JEFFERSON</b>	<b>DISTRICT ATTORNEYS</b> Increases the salary of the district attorney
_____	<b>HB 446</b>	<b>CARTER, S.</b>	<b>STUDENT/LOANS-SCHOLARSHIP</b> Provides for a voucher program for certain public school students
_____	<b>HB 485</b>	<b>JAMES</b>	<b>TAX/EXCISE</b> Authorizes the levy of an excise tax on cannabis
_____	<b>HB 587</b>	<b>MARINO</b>	<b>TAX/GAMING</b> Levies a state tax on the net proceeds of sports wagering, dedicates the avails of the tax, and imposes certain gaming fees
_____	<b>HB 599</b>	<b>HARRIS, L.</b>	<b>TAX/SALES &amp; USE</b> Reduces the rate of the .45% state sales and use tax levy over a certain period of time
_____	<b>SB 22</b>	<b>JOHNS</b>	<b>FUNDS/FUNDING</b> Dedicates funds from certain litigation filed by the state to recover damages. (gov sig)
_____	<b>SB 116</b>	<b>HENSGENS</b>	<b>COMMERCIAL REGULATIONS</b> Provides for the transfer of certain deposits and safe

deposit box contents to the unclaimed property division of the Department of the Treasury. (7/1/19)
