HB 275	RISER (TBA)	TAX/INCOME TAX (Constitutional Amendment) Eliminates the mandate for the corporation income tax deduction for federal income taxes paid (Subject to Rule Suspension)
HB 369	IVEY (TBA)	TAX/INCOME TAX (Constitutional Amendment) Provides for a flat tax on individual income and eliminates the mandatory income tax deduction for federal income taxes paid for purposes of computing income taxes (Subject to Rule Suspension)
HB 370	IVEY	TAX/AD VALOREM-EXEMPTION (Constitutional Amendment) Establishes certain property tax exemptions for capital investment projects
HB 376	IVEY (TBA)	TAX/INCOME TAX Provides for a flat tax rate for purposes of calculating income tax for individuals, estates, and trusts and modifies income tax credits and deductions (Subject to Rule Suspension)
HB 417	IVEY (TBA)	FUNDS/FUNDING (Constitutional Amendment) Revises Article VII of the Constitution of Louisiana (Subject to Rule Suspension)
HB 464	IVEY	TAX/AD VALOREM-EXEMPTION Provides for ad valorem tax exemptions for certain capital investment projects
HB 486	DEVILLIER	TAX/SALES-USE-EXEMPT (Constitutional Amendment) Provides relative to state sales and use tax exemptions for food for home consumption, utilities for residential use, and prescription drugs
HB 628	STEFANSKI	GAMING Provides for sports wagering
HB 629	IVEY	TAX Provides relative to individual income tax, corporation income tax, corporation franchise tax, and ad valorem tax

A. Any interested person or any committee member may file with the committee a prepared statement concerning a specific instrument or matter under consideration by the committee or concerning any matter within the committee's scope of authority, and the committee records shall reflect receipt of such statement and the date and time thereof.

B. Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
