Consideration and approval of Site Code: 2-17-015, LDH site, Champion Office Complex at 4615 Government St., Baton Rouge, eight (8) acres, two buildings, both two stories, with a total of 59,189 square feet of gross building area, 242 parking spaces, appraised at \$4.255 million dollars as of January 24, 2019; reappraised at \$3.38 million as of April 30, 2021.
