_____	<b>HB 917</b>	<b>BEAULLIEU</b>	<b>TAX/INCOME TAX</b> Reduces certain rates for purposes of calculating individual income tax liability and the tax liability for estates and trusts
_____	<b>HB 972</b>	<b>PHELPS</b>	<b>FEES/LICENSES/PERMITS</b> Establishes an amnesty program for fines, fees, and assessments imposed by state agencies
_____	<b>HCR 72</b>	<b>ROMERO</b>	<b>TAX/TAXATION</b> Urges and Requests the chairmen of the House Committee on Ways and Means and the Senate Committee on Revenue and Fiscal Affairs to establish a joint subcommittee to study state tax incentives and rebates
_____	<b>HCR 104</b>	<b>WRIGHT</b>	<b>REVENUE DEPARTMENT</b> Urges and requests the Dept. of Revenue to study and report on the feasibility of accepting virtual currency as a form of payment of taxes, licenses, fees, penalties, and interest due to the state
_____	<b>SB 28</b>	<b>ALLAIN</b>	<b>REVENUE DEPARTMENT</b> Provides relative to state partnership audit adjustments. (8/1/22)
_____	<b>SB 54</b>	<b>ALLAIN</b>	<b>REVENUE DEPARTMENT</b> Provides for an automatic filing extension for individual income tax returns. (8/1/22)
_____	<b>SB 235</b>	<b>ALLAIN</b>	<b>TAX/LOCAL</b> Authorizes parishes to contract with the Louisiana Sales and Use Tax Commission for Remote Sellers for the collection of local sales and use tax. (1/1/23)

_____	<b>SB 241</b>	<b>ALLAIN</b>	<b>TAX/TAXATION</b> Provides for alternatives in lieu of payment under protest for certain ad valorem taxes. (8/1/22)
_____	<b>SB 244</b>	<b>ALLAIN</b>	<b>TAX/LOCAL</b> Requires uniform reporting by local sales tax collectors that are compensated based on cost of collection. (8/1/22)
_____	<b>SB 443</b>	<b>ALLAIN</b>	<b>TAX/SALES</b> Provides for direct payment of state and local sales tax on purchases by certain taxpayers. (1/1/23)
_____	<b>SB 444</b>	<b>ALLAIN</b>	<b>TAX/TAXATION</b> Provides relative to tax administration and the Board of Tax Appeals. (2/3 - CA7s2.1(A)) (gov sig)

A. Any interested person or any committee member may file with the committee a prepared statement concerning a specific instrument or matter under consideration by the committee or concerning any matter within the committee's scope of authority, and the committee records shall reflect receipt of such statement and the date and time thereof.

B. Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
