_____	<b>HB 3</b>	<b>BISHOP, S.</b>	<b>CAPITAL OUTLAY</b> Provides for the Omnibus Bond Act
_____	<b>HB 250</b>	<b>BISHOP, S.</b>	<b>ASSESSORS</b> Authorizes assessors in each parish to increase their annual compensation during a term of office
_____	<b>HB 363</b>	<b>NELSON</b>	<b>TAX/TAXATION</b> Phases-out the corporation income and franchise taxes and reduces the amount of exemptions, deductions, and credits that may be claimed to reduce corporate income and franchise tax liability
_____	<b>HB 414</b>	<b>NELSON</b>	<b>TAX</b> (Constitutional Amendment) Provides relative to various sources of state and local revenue
_____	<b>HB 423</b>	<b>NELSON</b>	<b>TAX</b> Provides relative to state and local sales and use taxes
_____	<b>HB 424</b>	<b>NELSON</b>	<b>TAX/INCOME TAX</b> Phases-out the taxes levied on the income of individuals and estates and trusts and reduces the amount of exemptions, deductions, and credits that may be claimed to reduce income tax liability
_____	<b>HB 437</b>	<b>NELSON</b>	<b>TAX/CORP INCOME</b> Provides for a flat rate for purposes of calculating the corporation income tax
_____	<b>HB 492</b>	<b>MARINO</b>	<b>TAX</b> Repeals a tax on marijuana and controlled dangerous substances

## VI. ADJOURNMENT

A. Any interested person or any committee member may file with the committee a prepared statement concerning a specific instrument or matter under consideration by the committee or concerning any matter within the committee's scope of authority, and the committee records shall reflect receipt of such statement and the date and time thereof.

B. Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
