 HB 153	DEVILLIER	<b>TAX/AD VALOREM-EXEMPTION</b> (Constitutional Amendment) Phases-in, over a four year period, a property tax exemption for items constituting business inventory
 HB 241	BEAULLIEU	<b>TAX/INCOME TAX</b> Provides for a flat rate for purposes of calculating the income tax for individuals, estates, and trusts
 HB 303	IVEY	<b>TAX/INCOME TAX</b> Provides for a flat rate for purposes of calculating income tax for individuals, estates, and trusts and modifies certain income tax deductions and credits
 HB 371	IVEY	<b>TAX/AD VALOREM-EXEMPTION</b> To establish the La. Economic Advancement Plan (LEAP) which provides for ad valorem tax exemptions for certain capital investment projects
 HB 382	GAROFALO	<b>TAX/INCOME TAX</b> Authorizes establishment of tax-advantaged catastrophe savings accounts to cover losses from damage to taxpayers' primary residences and commercial property
 HB 391	FONTENOT	<b>TAX/INCOME TAX</b> Authorizes an individual income tax deduction for property insurance premium costs for taxpayers' primary residences
 HB 428	PRESSLY	<b>TAX/INCOME TAX</b> Extends to estates, trusts, and partnerships the flow-through entity income exclusion allowed to individuals

HB 473	IVEY	<b>TAX/AD VALOREM-EXEMPTION</b> (Constitutional Amendment) Establishes certain property tax exemptions for capital investment projects

For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
