<b>HB 1</b>	<b>MCFARLAND</b>	<b>APPROPRIATIONS</b> Provides for the ordinary operating expenses of state government for Fiscal Year 2024-2025
<b>HB 291</b>	<b>MCFARLAND</b>	<b>REVENUE SHARING</b> Provides for the Revenue Sharing Distribution for Fiscal Year 2024-2025
<b>HB 314</b>	<b>MCFARLAND</b>	<b>APPROPRIATIONS/ANCILLARY</b> Provides for the ancillary expenses of state government
<b>HB 781</b>	<b>MCFARLAND</b>	<b>APPROPRIATIONS</b> Appropriates funds for the expenses of the judiciary for Fiscal Year 2024-2025
<b>HB 782</b>	<b>MCFARLAND</b>	<b>APPROPRIATIONS/SUPPLEML</b> Makes supplemental appropriations for Fiscal Year 2023-2024
<b>HB 786</b>	<b>MCFARLAND</b>	<b>FUNDS/FUNDING</b> Provides for the transfer, deposit, and use of monies among state funds
<b>HB 843</b>	<b>MCFARLAND</b>	<b>LEGISLATIVE EXPENSES</b> Makes appropriations for the expenses of the legislature for Fiscal Year 2024-2025
<b>HCR 3</b>	<b>MCFARLAND</b>	<b>HOSPITALS</b> Provides for a hospital stabilization formula

<b>HB 2</b>	<b>EMERSON</b>	<b>CAPITAL OUTLAY</b> Provides for the comprehensive Capital Outlay budget
<b>HCR 21</b>	<b>SCHLEGEL</b>	<b>SCHOOLS/FINANCE-MFP</b> Provides for legislative approval of the MFP formula for FY 2024-2025
