SB 220	KLEINPETER	CRIME/PUNISHMENT Authorizes law enforcement to impound any vehicle used in a drag race, or other enumerated action or event, at the owner's expense, for thirty days to gather evidence pertaining to the crime. (8/1/24)

SB 236	FOIL	MOTOR VEHICLES Establishes a driver's license designation and a special identification designation for a person with a seizure disorder. (8/1/24)
SB 302	CATHEY	TRAFFIC Prohibits issuing traffic violation citations in certain circumstances. (gov sig)
SB 379	MIGUEZ	TRANSPORTATION/DEV DEPT Provides relative to the Atchafalaya Basin Bridge. (8/1/24)
SB 389	PRICE	LEVEES Changes the name of the Lafourche Basin Levee District. (8/1/24)
