HB 306	OWEN, CHARLES	HEALTH CARE/FACILITIES Provides for visitation policies at certain healthcare facilities and requires that such policies allow for in-person visitation
HB 707	JORDAN	DRUGS Provides relative to the regulation of cannabis
HB 711	GALLE	VACCINES/VACCINATION Provides relative to parental consent with respect to the administration of vaccines to minors
HB 815	BILLINGS	HEALTH/LDH Provides relative to certain federally-regulated information
SB 46	MCMATH	HEALTH DEPARTMENT Creates the Alzheimer's and Related Dementias Advisory Council within the Louisiana Department of Health. (gov sig)
SB 73	WOMACK	WATER QUALITY Creates and provides for the Community Sewerage System Infrastructure Sustainability Act. (1/1/25)
SB 92	DUPLESSIS	CHILDREN'S CODE Provides relative to the Safe Haven Law. (8/1/24)
SB 165	MCMATH	CONTRACTS Provides relative to noncompetition agreements. (8/1/24)
SB 166	CONNICK	PUBLIC HEALTH Provides relative to seafood safety. (1/1/25)
SB 231	DUPLESSIS	MENTAL HEALTH Provides regarding involuntary outpatient treatment for mental health. (8/1/24)
SB 278	JACKSON-ANDREWS	CHILDREN Creates the Louisiana Pregnancy and Baby Care Initiative. (gov sig)
SB 296	BOUDREAUX	HEALTH CARE Provides relative to emergency medical services. (gov sig)
