INSTRUMENTS TO BE HEARD:

HB 509	BROWN, CHAD	INSURANCE/HEALTH Provides relative to pharmacy benefit managers
SB 48	TALBOT	GENETICS Provides for health insurance coverage of genetic testing for diseases and other medical conditions. (gov sig)
SB 58	TALBOT	INSURANCE POLICIES Provides for patient's right to prompt coverage. (gov sig)
SB 219	MCMATH	HEALTH/ACC INSURANCE Provides relative to conversion requirements for health insurers. (gov sig)
SB 242	BOUIE	INSURANCE POLICIES Provides for the use of satellite photos when inspecting a property that has been issued an insurance policy. (gov sig)
SB 270	TALBOT	HOUSING Provides relative to volunteer board members of certain interlocal risk management agencies. (gov sig)
SB 337	BOUDREAUX	INSURANCE PREMIUMS Provides for a premium discount for certain military personnel. (8/1/24)
SB 338	BOUDREAUX	HEALTH/ACC INSURANCE Requires health coverage plans to include alternative imaging methods to mammography. (gov sig)
SB 344	BARROW	INSURANCE POLICIES Requires an applicant or an existing insured regarding a homeowner's insurance policy to disclose to their insurer the property is to be used or is being used as a group home. (gov sig)
SB 345	BARROW	INSURANCE DEPARTMENT Provides for an extension for premiums due for homeowners' policies. (8/1/25)
SB 367	BASS	INSURANCE DEPARTMENT Provides for the boards and commissions within the Department of Insurance. (8/1/24)
