INSTRUMENTS TO BE HEARD:

<b>HR 94</b>	<b>WALTERS</b>	<b>HOUSE/RULES</b> Allows the child of a legislator to be on the floor in the House Chamber or in committee if the child is in the care of the legislator
<b>HCR 41</b>	<b>HORTON</b>	<b>LEGISLATIVE COMMITTEES</b> Requests a joint subcommittee of the House Committee on Appropriations and Senate Committee on Finance to study and make recommendations relative to state supplemental pay
<b>HCR 65</b>	<b>MCKIN</b>	<b>LEGISLATIVE AFFAIRS</b> Establishes the Young Republican Caucus of the Legislature of Louisiana
<b>HCR 66</b>	<b>MELERINE</b>	<b>LEGISLATIVE COMMITTEES</b> Provides for a joint legislative committee to study regulations regarding artificial intelligence
<b>HB 900</b>	<b>WYBLE</b>	<b>CONGRESS</b> Provides relative to the disclosure of certain information related to candidates for U.S. Senate and U.S. House of Representatives
<b>HB 925</b>	<b>MACK</b>	<b>JUDGMENTS</b> Provides relative to reporting requirements for political subdivisions associated with outstanding judgments
<b>SB 101</b>	<b>MIGUEZ</b>	<b>VOTERS/VOTING</b> Provides relative to ranked-choice voting and instant runoff voting. (gov sig)
<b>SB 133</b>	<b>PRESSLY</b>	<b>PUBLIC HEALTH</b> Provides relative to certain international organizations. (8/1/24)
<b>SB 226</b>	<b>CLOUD</b>	<b>VOTERS/VOTING</b> Provides relative to absentee by mail ballots. (8/1/24)
