| <b>HB 118</b> | <b>NEWELL</b>          | <b>LABOR/ARBITRATION</b> Provides relative to certain pre-dispute arbitration agreements in the workplace  |
| <b>HB 523</b> | <b>WILDER</b>          | <b>LABOR/COLLECTIVE BARGAIN</b> Provides relative to the election of a collective bargaining representative  |
| <b>HB 556</b> | <b>GLORIOSO</b>        | <b>WORKERS COMPENSATION</b> Provides relative to an injury producing the permanent total disability of an employee   |
| <b>HB 668</b> | <b>MELERINE</b>        | <b>WORKERS COMPENSATION</b> Provides relative to benefits and period of disability   |
| <b>HB 769</b> | <b>RISER</b>           | <b>WORKERS COMPENSATION</b> Creates a civil liability for denial of medical expenses   |
| <b>SB 293</b> | <b>EDMONDS</b>         | <b>WORKFORCE DEVELOPMENT</b> Provides primary point of contact for workforce solutions. (8/1/24)   |
| <b>SB 356</b> | <b>JACKSON-ANDREWS</b> | <b>WORKFORCE DEVELOPMENT</b> Provides for workforce training and education initiative for public assistance recipients. (8/1/24)   |
| <b>SCR 11</b> | <b>REESE</b>           | <b>CONGRESS</b> Urges the Congress of the United States to amend federal law to allow states to provide for the consolidation of federally funded workforce development services with federally funded social safety net services. |
