_____	<b>HB 902</b>	<b>MELERINE</b>	<b>RETIREMENT SYSTEMS</b> Requires fiduciaries for public retirement systems to make investment decisions based solely on financial factors
_____	<b>SB 405</b>	<b>KLEINPETER</b>	<b>SHERIFFS PEN/RELIEF FUND</b> To provide for retirees returning to positions covered by the Sheriffs' Pension and Relief Retirement Fund. (gov sig)
_____	<b>SB 406</b>	<b>KLEINPETER</b>	<b>RETIREMENT BENEFITS</b> Removes the cap on the amount of any permanent benefit increase for recipients whose benefit is based on the record of someone who retired with at least 30 years of service credit. (gov sig)
