<b>HB 226    FREIBERG</b>	<b>FUNDS/FUNDING</b> Provides for appropriation of certain monies in the East Baton Rouge Parish Enhancement Fund
<b>HB 245    ZERINGUE</b>	<b>SUPPLEMENTAL PAY</b> Provides relative to qualifications for state supplemental pay for firemen
<b>HB 283    TARVER, PHILLIP</b>	<b>APPROPRIATIONS</b> Limits the amount of recurring State General Fund (Direct) revenues that may be appropriated in a fiscal year for recurring expenses and restricts use of such revenues above that limit
<b>HB 295    TARVER, PHILLIP</b>	<b>APPROPRIATIONS</b> (Constitutional Amendment) Limits the amount of State General Fund (Direct) revenues that may be appropriated in a fiscal year for recurring expenses and restricts use of such revenues above that limit
<b>HB 346    DESHOTEL</b>	<b>FUNDS/FUNDING</b> To establish the Local Infrastructure Fund
<b>HB 347    GADBERRY</b>	<b>BUDGETARY PROCEDURES</b> Provides relative to Joint Legislative Committee on the Budget approval of capital outlay change orders
<b>HCR 7    BACALA</b>	<b>INSURANCE/GROUP-STATE</b> Authorizes and directs the state Office of Group Benefits to study and report to legislature regarding savings available from requiring eligible participants to enroll in Medicare and options for plan provisions that could return some of those savings to those participants
<b>HR 5      HORTON</b>	<b>SUPPLEMENTAL PAY</b> Authorizes and directs the legislative auditor to examine, investigate, and audit the firemen's supplemental pay program
