HB 342	BAYHAM	<b>ELECTIONS/CANDIDATES</b> Provides relative to qualifying fees and nominating petitions for certain candidates
HB 385	BRYANT	<b>PUBLIC OFFICIALS</b> Provides that the oath or affirmation of a public official shall be recorded at no charge to the official

HB 502	BUTLER	<b>REGISTRARS OF VOTERS</b> Provides for the compensation, evaluation, duties, and removal of registrars of voters
HB 590	SPELL, ANNIE	<b>ELECTIONS</b> Provides relative to foreign funding for elections and ballot measures
HB 603	MCMAKIN	<b>BOARDS/COMMISSIONS</b> Amends the appointing process for certain occupational licensing boards, committees, and authorities
HB 617	CARVER	<b>CHILDREN/DCFS</b> Reorganizes the Department of Children and Family Services
HB 624	BERAULT	WORKFORCE COMMISSION Transfers certain family and support programs from the Department of Children and Family Services to the Louisiana Workforce Commission and renames Louisiana Workforce Commission to Louisiana Works
HB 625	BUTLER	<b>ELECTIONS/SPECIAL</b> Provides for a special statewide election on April 18, 2026, for submitting proposed constitutional amendments to the state's electors
