HB 314	MILLER, D.	HEALTH CARE/FACILITIES Modifies the regulatory authority of the Louisiana Department of Health in relation to hospital classifications
HB 317	ECHOLS	HEALTH CARE/FACILITIES Establishes prohibited acts by certain healthcare facility lessors and lessees
HB 358	MILLER, D.	PHARMACISTS Permits a pharmacy technician to work remotely in certain circumstances
HB 399	CHENEVERT	DIETITIANS Provides with respect to the profession of dietetics and dieticians
HB 454	MILLER, D.	MEDICAID Requires Medicaid coverage for certain doula services

HB 544	TURNER	HEALTH CARE Transfers powers and duties of the Nursing Supply and Demand Council and the Simulation Medical Training and Education Council to the Louisiana Health Works Commission
HB 565	SPELL, ANNIE	MEDICAID Provides relative to third-party liability, claim adjudication, and timeliness of such within the state medical assistance program
