HB 633	BRAUD	LEVEES/BDS & DISTRICTS Provides relative to the boards of commissioners for the Southeast Louisiana Flood Protection Authority-East and the Southeast Louisiana Flood Protection Authority-West Bank
HB 651	YOUNG	DISTRICTS/AIRPORT Creates Claiborne Parish Airport District No. 31
HB 660	BOYD	TRANSPORTATION Provides relative to the annual registration tax applicable to trucks and trailers statewide
