<b>HB 237</b>	<b>MACK</b>	<b>STUDENTS</b> Provides relative to the use of seclusion and physical restraint to address the behavior of students with exceptionalities
<b>HB 243</b>	<b>LANDRY, MANDIE</b>	<b>STUDENT/ASSESSMENT</b> Provides relative to student assessment and school accountability with respect to the Louisiana Giving All True Opportunity to Rise (LA GATOR) Scholarship Program
<b>HB 344</b>	<b>BERAULT</b>	<b>STUDENT/DISCIPLINE</b> Provides for the transfer of school disciplinary records and for school personnel's access to certain juvenile court records
<b>HB 384</b>	<b>BRYANT</b>	<b>STUDENT/DISCIPLINE</b> Provides relative to disciplinary penalties for certain public school students found to be in possession of certain substances on school property
<b>HB 486</b>	<b>FISHER</b>	<b>HEALTH</b> Requires public schools to offer a mental health assessment to certain students
