<b>HB 1049</b>	<b>OWEN, CHARLES</b>	<b>PUBLIC MEETINGS</b> Provides relative to public meetings
<b>HB 1057</b>	<b>WALTERS</b>	<b>VOTERS/VOTING</b> Provides for an application to vote absentee by mail made by a member of the United States Service
<b>HB 1131</b>	<b>MARCELLE</b>	<b>ELECTIONS</b> Provides relative to voter registration
<b>HB 1177</b>	<b>ZERINGUE</b>	<b>PUBLIC RECORDS</b> Establishes a public records exemption for personal information related to hunting and fishing licenses
