<b>SB 222</b>	<b>PRESSLY</b>	<b>BEHAVIORAL HEALTH</b> Provides for Medicaid behavioral health services. (gov sig)
<b>SB 255</b>	<b>SELDERS</b>	<b>BEHAVIORAL HEALTH</b> Provides relative to psychosocial rehabilitation (PSR) services. (8/1/26)
<b>SB 314</b>	<b>SELDERS</b>	<b>BEHAVIORAL HEALTH</b> Provides relative to community psychiatric support and treatment (CPST) services. (gov sig)
<b>SB 427</b>	<b>PRESSLY</b>	<b>DONATIONS</b> Provides for procedures and methods to execute gifts under the Anatomical Gift Act. (1/1/27)
<b>SCR 2</b>	<b>MYERS</b>	<b>HOSPITALS</b> Amends rules relative to certain licensure requirements of hospitals.
<b>SCR 22</b>	<b>MYERS</b>	<b>PHARMACEUTICALS</b> Requests a legislative auditor report on opioid settlement fund expenditures.
