<b>HB 13</b>	<b>MCKIN</b>	<b>RETIREMENT/STATE POLICE</b> Provides relative to amortization bases within the Louisiana State Police Retirement System
<b>HB 14</b>	<b>WILDER</b>	<b>RETIREMENT/TEACHERS</b> Provides relative to beneficiaries within the Teachers' Retirement System of Louisiana
<b>HB 23</b>	<b>BACALA</b>	<b>RETIREMENT/STATE EMPS</b> Grants a cost-of-living adjustment to eligible retirees and beneficiaries
<b>HB 24</b>	<b>OWEN, CHARLES</b>	<b>RETIREMENT/TEACHERS</b> Provides relative to the reemployment of retirees through a contract within the Teachers' Retirement System of Louisiana
<b>HB 25</b>	<b>SPELL, ANNIE</b>	<b>RETIREMENT/TEACHERS</b> Provides relative to the payment of benefits for the Teachers' Retirement System of Louisiana
<b>HB 32</b>	<b>EGAN</b>	<b>RETIREMENT/STATE EMPS</b> Provides relative to the Louisiana State Employees' Retirement System
<b>HB 42</b>	<b>BACALA</b>	<b>RETIREMENT/TEACHERS</b> Provides relative to a phased retirement program within the Teachers' Retirement System of Louisiana
