Minutes of Meeting 2012 Regular Session Tuesday, May 29, 2012

I. CALL TO ORDER

Representative Joel C. Robideaux, chairman of the House Committee on Ways and Means, called the meeting to order at 11:24 a.m. in House Committee Room 6 of the State Capitol, Baton Rouge, Louisiana. The secretary called the roll and a quorum was established.

III. DISCUSSION OF LEGISLATION

Discussion of legislation opened with a presentation of Senate Bill 351 by Mr. Rodney Braxton for Senator Murray. Pending the drafting of proposed amendments, further discussion of the bill was postponed until the end of the meeting.

Senate Bill No. 361 by Senator Morrell

Senator Morrell presented Senate Bill No. 361, which would provide relative to 9-1-1 fees for the Orleans Communication District. The bill was presented to the committee on May 21, 2012, and a motion to report the bill with amendments failed by a vote of 7 yeas and 10 nays. The set of amendments to clarify the election language, which were offered at that meeting by Representative Wesley Bishop, were distributed again to the members. The set of amendments previously adopted by the House Committee on Municipal, Parochial, and Cultural Affairs were also distributed to the members. Those amendments changed the dollar amount from \$1.89 to \$2.00 per residential access line and from \$3.38 to \$3.00 per commercial access line; and provided for a \$2.00 per month residential broadband connection and a \$3.00 per month commercial broadband connection.

Representative Thibaut offered a set of amendments to dedicate the proceeds to the Orleans Communication District. He also offered a motion to adopt the amendments, to which there was no objection. The amendments were adopted by a vote of 15 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hazel, Hoffmann, Lorusso, Robideaux, Thibaut, Whitney, and Patrick Williams.

There was no further discussion on the bill.

Representative Barrow offered a motion to report Senate Bill No. 361 with amendments, to which Representative Robideaux objected. The bill was reported with amendments by a vote of 15 yeas and 2 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hazel, Hoffmann, Johnson, Lorusso, Thibaut, Whitney, and Willmott. Representatives Robideaux and Patrick Williams voted nay.

Senate Bill No. 605 by Senator Gallot

Mr. Chris Young presented Senate Bill No. 605 for Senator Gallot, which would provide for procedures and notifications required for tax sales.

Representative Barras offered a set of amendments to strengthen the presale notification process; reduce the number of post sale notifications to one; and added language to allow a tax-sale purchaser to send the notices, to which there was no objection. The amendments were adopted by a vote of 16 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hazel, Hoffmann, Johnson, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

Representative Barras offered a set of amendments to remove 35 parishes from the bill, to which Representative Thibaut objected. The motion to adopt the amendments failed by a vote of 7 yeas and 10 nays. Those voting yea were Representatives Barras, Burford, Danahay, Hazel, Johnson, Robideaux, and Willmott. Representatives Adams, Barrow, Wesley Bishop, Broadwater, Guillory Hoffmann, Lorusso, Thibaut, Whitney, and Willmott voted nay.

There was no further discussion on the bill.

Representative Adams offered a motion to report Senate Bill No. 605 with amendments, to which there was no objection. The bill was reported with amendments by a vote of 17 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hazel, Hoffmann, Johnson, Lorusso, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

Senate Bill No. 351 by Senator Murray

Discussion resumed with Mr. Rodney Braxton presenting Senate Bill No. 351 for Senator Murray, which would authorize Orleans and Jefferson Parishes to establish an automobile rental tax district and to levy an automobile rental tax not to exceed 3%, beginning July 1, 2012.

Representative Willmott offered a set of amendments to clarify the distribution of taxes within Jefferson Parish. He also offered a motion to adopt the amendments, to which there was no objection. The amendments were adopted by a vote of 16 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hoffmann, Johnson, Lorusso, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

There was no further discussion on the bill.

Representative Wesley Bishop offered a motion to report Senate Bill No. 351 with amendments, to which there was no objection. The bill was reported with amendments by a vote of 16 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hoffmann, Johnson, Lorusso, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.
