Minutes of Meeting 2014 Regular Session March 27, 2014

I. CALL TO ORDER

Representative J. Kevin Pearson, chairman of the House Committee on Retirement, called the meeting to order at 9:19 a.m. in Room 4, in the State Capitol in Baton Rouge, Louisiana. The secretary called the roll.

III. DISCUSSION OF LEGISLATION

House Bill No. 6 by Representative Pearson

Representative Pearson presented House Bill No. 6, which establishes a minimum employer contribution rate for the Optional Retirement Plan (ORP) in the Teachers' Retirement System of Louisiana (TRSL).

Representative Pearson offered amendments to remove provisions establishing the portion of the employer contribution rate credited to ORP member accounts at the greater of the normal cost or 6.25% of pay; add a provision allowing each higher education board to establish a rate to be contributed to its employees' ORP accounts and the schedule for same; and add provisions for contributions for all employers that are not postsecondary education management boards or an employer or agency under the control of such a board.

Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Pearson, Lorusso, Hoffmann, Hollis, Ivey, Jones, Miller, Price, Reynolds, and Talbot voted yea.

House Bill No. 67 by Representative Montoucet

Representative Montoucet presented House Bill No. 67, which provides that the benefit accrual rate for members of the Firefighters Retirement System first hired on or after July 1, 2014, is based on length of service and extends maximum DROP participation from three to five years for members with 30 or more years of service.

Mr. Chad Major, Professional Firefighters Association (PFFA), (address illegible), Baton Rouge, LA, 225-572-8483, spoke in favor of the bill.

Mr. Paul Richmond, actuarial services manager, Office of the Legislative Auditor, explained his conclusion that there would be upfront costs to the system based on provisions in the bill.

Ms. Stephanie Little, staff attorney, explained a proposed amendment offered by Representative Montoucet.

During discussion, Representative Montoucet changed the amendment to pertain only to in-servicedisabled members of the system.

Representative Jones offered a motion to adopt the proposed amendments with the described changes. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Pearson, Lorusso, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representatives Pearson, Lorusso, Hollis, Ivey, Miller, and Talbot voted nay.

House Bill No. 90 by Representative Barrow

Representative Price presented House Bill No. 90 on behalf of the author. The bill, a companion to a constitutional amendment, requires occasional supplemental payments to retirees and beneficiaries of the four state retirement systems from monies available from the Seniors' Supplemental Fund.

Representative Price offered a set of technical amendments.

Representative Price offered a motion to adopt the proposed technical amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Lorusso, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.
