Minutes of Meeting 2014 Regular Session April 24, 2014

III. DISCUSSION OF LEGISLATION

House Bill No. 1225 by Representative Robideaux

Representative Robideaux and Senator Guillory presented House Bill No. 1225, which requires the four state retirement systems (Louisiana State Employees' Retirement System (LASERS), Teachers' Retirement System of Louisiana (TRSL), Louisiana School Employees' Retirement System (LSERS), and State Police Retirement System (STPOL) to apply certain amounts of excess investment returns to their outstanding debt and limits creation of additional liabilities through benefit increases.

Representative Pearson offered a set of amendments which Ms. Little explained would exclude particularized liabilities in varience contribution debts for all four systems from required payments on "oldest" debt of the system; reinsert some present law into the bill; provide for a 10-year amortization for purposes of determining whether the balance in the experience account is sufficient to fully fund, on an actuarial basis, any increase granted on or after July 1, 2015, calculated using a 10-year amortization period, and any recalculation of prior amortization bases created as a result of credits to the account being adjusted accordingly; provide relative to payments for LASERS and TRSL; provide relative to payments to the experience account; add, for LSERS and STPOL, provisions establishing each system's current assumed rate of return as a threshold for granting a benefit increase above 2%; require a report to the House and Senate Committees on Retirement by September 2, 2014 and review and approval by the joint committee by December 31, 2014; and to provide for the effective date of the Act.

Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Pearson, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representative Pearson offered a set of technical amendments which Ms. Little said would make changes to the previously adopted amendment to the effect that actuarial gains allocated to the experience accounts shall be amortized as a loss with level payments over a ten-year period.

Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Pearson, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representative Pearson offered a set of amendments that Ms. Little explained would remove provisions restricting the granting of benefit increases to every other year when the system is above 85% funded.

Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Pearson, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representative Pearson offered a set of amendments which Ms. Little explained would add a provision authorizing each system to grant a partial benefit increase under certain circumstances.

Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Pearson, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

House Bill No. 22 by Representative Pearson

Representative Pearson presented House Bill No. 22, which relative to the Harbor Police Retirement System in the city of New Orleans, increases service required for eligibility for disability benefits, authorizes payment of benefits to handicapped or disabled children, removes certain specified actuarial assumptions, and provides relative to the board of trustees.

Representative Havard presented House Bill No. 64, which provides that certain employees of the Eastern La. Mental Health System are eligible for membership in the Hazardous Duty Services Plan in the La. State Employees' Retirement System (LASERS).

Representative Talbot offered a set of amendments which Ms. Little explained would restrict applicability of present law to employees of the system who are employed as therapeutic corrections guards or officers in the forensic program and add references to proposed law regarding therapeutic guards and officers to provisions with respect to membership and benefit calculations in the Hazardous Duty Services Plan.

Representative Talbot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Pearson, Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

House Bill No. 67 by Representative Montoucet

Representative Montoucet presented House Bill No. 67, which provides that the benefit accrual rate for members of the Firefighters Retirement System (FRS) first hired on or after July 1, 2014, is based on length of service and extends maximum DROP participation from three to five years for members with 30 or more years of service. The bill was heard and amended at the March 13, 2014 meeting with no final action taken.

Representative Talbot offered a motion to reconsider the vote by which amendments had been adopted at the earlier meeting. Without objection, the committee voted to reconsider such vote by a vote of 9 yeas and 0 nays. Representatives Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representative Ivey offered a set of amendments to add a provision making 3-1/3% accrual rate applicable to certain disability and survivor benefits for new hires with less than 30 years of service.

Representative Ivey offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, Reynolds, and Talbot voted yea.

Representative Ivey offered a motion to report House Bill No. 67 with amendments, to which Representative Talbot objected. A roll call vote was taken, and House Bill No. 67 was reported with amendments by a vote of 8 yeas and 1 nays. Representatives Hoffmann, Hollis, Ivey, Jones, Miller, Montoucet, Price, and Reynolds voted yea. Representative Talbot voted nay.

House Bill No. 78 by Representative Montoucet

House Committee on Retirement

Representative Montoucet presented House Bill No. 78, which provides relative to retirement benefits of adult probation and parole officers in the Louisiana State Employees Retirement System (LASERS).

Representatives Pearson, Hoffmann, Miller, Reynolds, and Talbot voted nay.

Representative Pearson offered a motion to involuntarily defer action on House Bill No. 78, to which Representative Ivey objected. A roll call vote was taken and by a vote of 4 yeas and 5 nays, the motion failed to pass. Representatives Pearson, Hoffmann, Miller, and Talbot voted yea. Representatives Ivey, Jones, Montoucet, Price, and Reynolds voted nay.

There was no final action taken on the bill.

House Bill No. 79 by Representative Pearson

Representative Pearson presented House Bill No. 79, which provides for enrollment of new hires of the Harbor Police Department of the Port of New Orleans in the Hazardous Duty Services Plan in the La. State Employees' Retirement System (LASERS) and for administration of the Harbor Police Retirement System by the LASERS.
