III. DISCUSSION OF LEGISLATION

House Bill No. 31 by Representative Jones

Representative Jones presented House Bill No. 31, which provides a permanent benefit increase paid from the experience account to certain retired members and beneficiaries of the Teachers' Retirement System of Louisiana.

Mr. Graig Luscombe, Louisiana Retired Teachers Assn., 9412 Common St., Baton Rouge, LA, 225-927-8837, spoke in favor of the bill.

Mr. Tom Tate, Louisiana Association of Educators (LAE), 8322 One Calais St., Baton Rouge, LA; Ms. M.P. Wray, Louisiana Federation of Teachers, 9623 Brookline Ave., Baton Rouge, LA; Mr. Shane Riddle and Ms. Debbie Meaux, LAE, 8322 One Calais Ave., Baton Rouge, LA, 343-9243; Ms. Gretchen Lampe, LAE, 300 Washington, St., #100A, Monroe, LA; 318-387-0536; and Ms. Judy McShea, St. Bernard Association of Educators, 2815 Delile St., Chalmette, LA, 504-232-2815, submitted cards indicating their support for the bill.

Ms. Maureen Westgard, director, Teachers' Retirement System of La., 8401 United Plaza Blvd., Baton Rouge, LA, submitted a card for information and stated that the TRSL board supports House Bill No. 31.

Mr. Ben Huxen, representing the commissioner of administration, (no address provided), 225-342-1046, informed the committee that the commissioner favors the various Senate bills over the House bills that are tied to House Bill No. 1225 relative to COLA's due to savings included in the former.

Representative Jones requested amendments to track the language from the respective Senate Bills referred to by the representative of the administration, which Representative Pearson said would not be allowed by committee practice precluding in-concept amendments.

Representative Montoucet offered a motion to report House Bill No. 31 favorably, to which Representative Pearson objected. A roll call vote was taken and by a vote of 4 yeas and 4 nays, the motion failed to pass. Representatives Hoffmann, Jones, Montoucet, and Price voted yea. Representatives Pearson, Ivey, Lorusso, and Miller voted nay.

There was no final action taken on the bill.

House Bill No. 30 by Representative Jones

Representative Jones presented House Bill No. 30, which provides a permanent benefit increase paid from the experience account to certain retired members and beneficiaries of the Louisiana State Employees' Retirement System.

Ms. Cindy Rougeau, LASERS, 8401 United Plaza Blvd., Baton Rouge, LA, 225-922-0604, submitted a card for information indicating that the LASERS board supports House Bill No. 30.

Mr. Ben Huxen, representing the commissioner of administration (no address provided), 225-342-1046, informed the committee that the administration prefers the Senate package of bills over the House package relative to COLA's.

Representative Montoucet offered a motion to report House Bill No. 30 favorably, to which Representative Ivey objected. A roll call vote was taken and by a vote of 4 yeas and 4 nays, the motion failed to pass. Representatives Hoffmann, Jones, Montoucet, and Price voted yea. Representatives Pearson, Ivey, Lorusso, and Miller voted nay.

There was no final action taken on the bill.

House Bill No. 34 by Representative Jones

Representative Jones presented House Bill No. 34, which provides a supplemental benefit increase to qualifying retirees and beneficiaries of the La. State Employees' Retirement System, but requested that the bill be rescheduled for hearing at a subsequent meeting.

Ms. Ayn Stehr, National Association of Social Workers, 18906 Spyglass Hill, Baton Rouge, LA, 225-241-0947, and Mr. Frank Jobert, Jr., RSEA, 9412 Common St., Suite 7, Baton Rouge, LA 225-930-0961, submitted cards indicating their support for the measure.

Ms. Cindy Rougeau, LASERS, 8401 United Plaza Blvd., Baton Rouge, LA, 225-922-0604, submitted a card for information indicating that the LASERS board supports House Bill No. 34.

Mr. Ben Huxen, representing the commissioner of administration (no address provided), 225-342-1046, submitted a card for information but did not testify.

Representative Jones offered a motion to voluntarily defer action on House Bill No. 34. Without objection, action on House Bill No. 34 was voluntarily deferred by a vote of 8 yeas and 0 nays. Representatives Pearson, Hoffmann, Ivey, Jones, Lorusso, Miller, Montoucet, and Price voted yea.

House Bill No. 35 by Representative Jones

House Bill No. 35 provides a supplemental benefit increase to certain qualifying retirees and beneficiaries of the La. School Employees' Retirement System.

There was no discussion on the bill. Representatiave Jones requested that the bill be rescheduled for hearing at a subsequent meeting.

Representative Jones offered a motion to voluntarily defer action on House Bill No. 35. Without objection, action on House Bill No. 35 was voluntarily deferred by a vote of 8 yeas and 0 nays. Representatives Pearson, Hoffmann, Ivey, Jones, Lorusso, Miller, Montoucet, and Price voted yea.

House Bill No. 36 by Representative Jones

House Bill No. 36 provides a supplemental benefit increase to qualifying retirees and beneficiaries of the State Police Retirement System.

There was no discussion on the bill. Representative Jones requested that the bill be rescheduled for hearing at a subsequent meeting.

Representative Jones offered a motion to voluntarily defer action on House Bill No. 36. Without objection, action on House Bill No. 36 was voluntarily deferred by a vote of 8 yeas and 0 nays. Representatives Pearson, Hoffmann, Ivey, Jones, Lorusso, Miller, Montoucet, and Price voted yea.

House Bill No. 33 by Representative Jones

House Bill No. 33 provides a permanent benefit increase paid from the experience account to certain retired members and beneficiaries of the La. School Employees' Retirement System.

There was no discussion on the bill. Representative Jones requested that the bill be rescheduled for hearing at a subsequent meeting.
