## III. DISCUSSION OF LEGISLATION

# **House Bill No. 584 by Representative Leger**

Representative Leger presented House Bill No. 584, which created a special fund for the purpose of funding Early Childhood Education in Louisiana.

Representative Leger offered a set of amendments to provide for a new method of distribution of the funds, and offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 20 yeas and 0 nays. Representatives Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Carter, Chaney, Edmonds, Foil, Harris, Hensgens, Hodges, Leger, McFarland, Miller, Pylant, Schroder, Simon, and Smith voted yea.

Representative Foil offered a set of amendments to create the Achieving a Better Life Experience in Louisiana Fund (ABLE Fund), and he offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 19 yeas and 0 nays. Representatives Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Carter, Chaney, Edmonds, Foil, Harris, Hodges, Leger, McFarland, Miller, Pylant, Schroder, Simon, and Smith voted yea.

There was no further discussion on the bill.

Representative Chaney offered a motion to report House Bill No. 584 with amendments. Without objection, House Bill No. 584 was reported with amendments by a vote of 20 yeas and 0 nays. # **House Bill No. 413 by Representative Leger**

Representative Leger presented House Bill No. 413, which provided relative to the funding of public defenders.

Representative Leger offered a set of amendments to specify that funds are to be used as the Public Defender Board deems appropriate and not to be used for any particular district defender office. He also offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 19 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Carter, Chaney, Edmonds, Foil, Harris, Hensgens, Leger, McFarland, Miller, Pylant, Schroder, Simon, and Zeringue voted yea.

There was no further discussion on the bill.

Representative Carter offered a motion to report House Bill No. 413 with amendments. Without objection, House Bill No. 413 was reported with amendments by a vote of 18 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Berthelot, Billiot, Carter, Chaney, Edmonds, Foil, Harris, Leger, Miller, Pylant, Schroder, Simon, Smith, and Zeringue voted yea.

# House Bill No. 184 by Representative Abraham

Representative Abraham presented House Bill No. 184, which created the Louisiana Jobs Now Fund for the purpose of funding Postsecondary Education degree and certificate production in high-demand fields.

Representative Abraham offered a set of amendments to specify that the amount deposited is equal to the amount of credits and exemptions taken in the last year the credit was available; increases the fund's match rate; and requires the Board of Regents to track the jobs created from the fund. He also offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Berthelot, Carter, Chaney, Edmonds, Foil, Miller, Pylant, Simon, Smith, and Zeringue voted yea.

Representative Foil offered a set of amendments to create the ABLE Fund, and he offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Berthelot, Carter, Chaney, Edmonds, Foil, Harris, Miller, Pylant, Simon, Smith, and Zeringue voted yea.

Representative Smith offered a motion to report House Bill No. 184 with amendments. Without objection, House Bill No. 184 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Carter, Chaney, Edmonds, Foil, Harris, Hodges, Miller, Simon, and Smith voted yea.

## **House Bill No. 255 by Representative Carter**

Representative Carter presented House Bill No. 255, which allowed for the use of the Budget Stabilization Fund for the state costs associated with a declared disaster.

Representative Carter offered a set of amendments to provide for deposits back into the fund from monies received by the state from the federal government for the reimbursement of costs related to a declared disaster. He also offered a motion to adopt the amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Henry, Amedée, Bacala, Berthelot, Carter, Chaney, Edmonds, Foil, Harris, Miller, Pylant, Schroder, Simon, and Smith voted yea.

Representative Smith offered a motion to report House Bill No. 255 with amendments. Without objection, House Bill No. 255 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Henry, Amedée, Bacala, Berthelot, Carter, Chaney, Edmonds, Foil, Harris, Miller, Pylant, Schroder, Simon, and Smith voted yea.
