#### III. DISCUSSION OF LEGISLATION

## House Bill No. 161 by Representative Garofalo

Representative Garofalo presented House Bill No. 161, which provides, under specified circumstances, for repayment of a Taylor Opportunity Program for Students (TOPS) award.

Representative Henry offered a motion to voluntarily defer action on House Bill No. 161. Without objection, action on House Bill No. 161 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Henry, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Hensgens, McFarland, Miguez, Simon, Smith, and Zeringue voted yea.

# House Bill No. 844 by Representative Garofalo

Representative Garofalo presented House Bill No. 844, which provides relative to the indemnification of clerks of court and their employees.

# **House Bill No. 142 by Representative Lyons**

Representative Lyons presented House Bill No. 142, which increases the waste tire disposal fee applicable to passenger and light truck tires.

Representative Miguez offered amendments to sunset the fee increase per passenger/light truck/small farm service tire on July 31, 2022. Representative Miguez also offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 16 yeas and 0 nays. Representatives Henry, Abraham, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, Smith, and Zeringue voted yea.

## House Bill No. 478 by Representative Bacala

Representative Bacala presented House Bill No. 478, which dedicates a portion of the state sales and use taxes on sales of motor vehicles for transportation projects based on a cost-benefit analysis.

Representative Bacala offered amendments to change the oversight committee from the Joint Highway Priority Construction Committee to the Joint Committee on Transportation, Highways, and Public Works. Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 17 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, Smith, and Zeringue voted yea.

Representative Bacala offered amendments to change the dates for submission of guidelines and lists of recommended projects to the oversight committee. Representative Bacala also offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Chaney, Edmonds, Falconer, Harris, McFarland, Miguez, Simon, Smith, and Zeringue voted yea.

# **House Bill No. 873 by Representative Hilferty**

Representative Hilferty presented House Bill No. 873, which dedicates any new revenue realized as a result of the enactment of legislation relative to sports betting and other forms of gaming to the La. Early Childhood Education Fund.

Representative Henry offered a motion to voluntarily defer action on House Bill No. 873. Without objection, action on House Bill No. 873 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Henry, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, McFarland, Miguez, Simon, and Zeringue voted yea.

### **House Bill No. 590 by Representative Edmonds**

Representative Edmonds presented House Bill No. 590, which creates the Efficient Government Act and provides for the Council on Efficient Government and its powers and duties.

Representative Edmonds offered a motion to report House Bill No. 590 favorably. Without objection, House Bill No. 590 was reported favorably by a vote of 16 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, and Zeringue voted yea.

## House Bill No. 538 by Representative Dwight

Representative Dwight presented House Bill No. 538, which provides for a magistrate judge in the 14<sup>th</sup> JDC.

Representative Henry offered amendments to eliminate duplicative language in the bill. Representative Henry offered a motion to adopt the proposed amendments. Without objection, the amendment was adopted by a vote of 16 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, and Zeringue voted yea.

Representative Miguez offered a motion to report House Bill No. 538 with amendments. Without objection, House Bill No. 538 was reported with amendments by a vote of 16 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, and Zeringue voted yea.

### House Bill No. 772 by Representative Amedée

Representative Amedée presented House Bill No. 772, which provides for an appropriation to the account of the Lafourche Parish School Board for Fiscal Year 2017-2018.

Representative Amedée offered a motion to voluntarily defer action on House Bill No. 772. Without objection, action on House Bill No. 772 was voluntarily deferred by a vote of 16 yeas and 0 nays. Representatives Henry, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Falconer, Lance Harris, Hensgens, McFarland, Miguez, Simon, Smith, and Zeringue voted yea.

## **House Bill No. 689 by Representative Stokes**

Representative Stokes presented House Bill No. 689, which provides for coverage for fertility preservation for individuals diagnosed with cancer.

Representatives Abraham, Amedée, Bacala, Bagley, Berthelot, Chaney, Edmonds, Falconer, Hensgens, Hodges, McFarland, Miguez, and Simon voted nay.

## Senate Bill No. 400 by Senator Hewitt

Senator Hewitt presented Senate Bill No. 400, which provides for certain funds in the state treasury and the powers, duties, functions, and responsibilities of the Dedicated Fund Review Subcommittee of the Joint Legislative Committee on the Budget.

Representative Chaney offered amendments which: (1) abolish the New Orleans Urban Tourism and Hospitality Training in Economic Development Fund and Higher Education Initiatives Fund; (2) change the Proprietary School Student Protection Fund to the Proprietary School Student Protection Account; (3) change the Office of Workers Compensation Administration Fund to the Office of Worker's Compensation Administration Account; and (4) eliminate the requirement that the subcommittee on statutory dedications meet only on the day that the Joint Legislative Committee on the Budget meets. Representative Chaney offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Henry, Abraham, Amedée, Bacala, Bagley, Berthelot, Billiot, Chaney, Edmonds, Harris, Hensgens, Hodges, McFarland, Simon, and Zeringue voted yea.

Representative Chaney offered amendments to restore the Medicaid Trust Fund for the Elderly. Representative Chaney also offered a motion to adopt the proposed amendments, to which Representative Edmonds objected. The secretary called the roll, and the amendments were adopted by a vote of 11 yeas and 4 nays. Representatives Henry, Abraham, Bagley, Billiot, Chaney, Harris, Hensgens, Hodges, McFarland, Miguez, and Zeringue voted yea. Representatives Bacala, Edmonds, Falconer, and Simon voted nay.

Representative McFarland offered amendments to remove the conversion of the Environmental Trust Fund to the Environmental Trust Account. Representative McFarland also offered a motion to adopt the proposed amendments, to which Representative Edmonds objected. The secretary called the roll, and the motion failed to pass by a vote of 6 yeas and 9 nays. Representatives Henry, Chaney, Harris, Hensgens, McFarland, and Zeringue voted yea. Representatives Abraham, Bacala, Berthelot, Billiot, Edmonds, Falconer, Hodges, Miguez, and Simon voted nay.

Representative McFarland offered amendments to remove the Pesticide Fund from funds converted to accounts. Representative McFarland also offered a motion to adopt the proposed amendments, to which Representative Edmonds objected.

The secretary called the roll, and the amendments were adopted by a vote of 11 yeas and 3 nays. Representatives Henry, Abraham, Bacala, Berthelot, Chaney, Harris, Hensgens, McFarland, Miguez, Simon, and Zeringue voted yea. Representatives Billiot, Edmonds, and Falconer voted nay.

Representatives Henry, Abraham, Bacala, Berthelot, Billiot, Chaney, Edmonds, Falconer, Harris, Hensgens, McFarland, Miguez, Simon, and Zeringue voted yea.
