III. DISCUSSION OF LEGISLATION

House Concurrent Resolution No. 15 by Representative Jordan

Representative Jordan presented House Concurrent Resolution No. 15, which requests that the Southern University Board of Supervisors submit a proposal to the Board of Regents for establishing an associate of applied science degree program in process technology and that the Board of Regents approve it.

House Bill No. 144 by Representative Abraham

Representative Nancy Landry offered a motion to adopt a three-minute rule for testimony on agenda items. Representative Abraham presented House Bill No. 144, which creates the Louisiana Jobs Now Fund for the purpose of funding postsecondary education degree and certificate production in high-demand fields.

Representative Leger offered amendments to the original bill to add institutions that are members of the Louisiana Association of Independent Colleges and Universities (LAICU) as eligible to receive and use monies in the Louisiana Jobs Now Fund. Representative Leger offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Steve Carter, Edmonds, Emerson, Falconer, Hall, Leger, Simon, Smith, and Thomas voted yea.

Representative Edmonds offered a motion to report House Bill No. 144 with amendments. Without objection, House Bill No. 144 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Leger, Simon, Smith, Thomas, and Wright voted yea.

Representative Thomas offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Leger, Simon, Smith, Thomas, and Wright voted yea.

Without objection, action on House Bill No. 632 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Emerson, Falconer, Hall, Hilferty, Simon, Smith, Thomas, and Wright voted yea.

House Bill No. 650 by Representative Foil

Representative Foil presented House Bill No. 650, which creates a program for education savings accounts for tuition expenses for elementary and secondary schools.

Representative Steve Carter offered amendments to the original bill that would remove proposed law providing for a "state match" (earnings enhancements) for Louisiana Student Tuition Assistance and Revenue Trust Kindergarten Through Grade Twelve (START K12) program accounts. Representative Steve Carter offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Emerson, Falconer, Hall, Hilferty, Simon, Smith, Thomas, and Wright voted yea.

House Bill No. 284 by Representative Smith

Representative Smith presented House Bill No. 284, which revises procedures relative to a student's inability to pay for school meals and a student's meal debt.

Representative Smith offered amendments to the original bill to:

1. Add requirement that state Department of Education (DOE) notify schools and distracts relative to eligibility to participate in federal Community Eligibility Provision; require DOE to assist them relative to this provision only if school or district requests assistance.

2. Authorize rather than require a school governing authority to contact the Department of Children and Family Services (DCFS) if a student owes money for at least 10 meals in a single school year; however, maintain the requirement for such notification if there is cause to believe the child is a victim of abuse or neglect.

Representative Smith offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Simon, Smith, and Wright voted yea.

Representative Smith offered amendments to the original bill to change requirement that school governing authorities provide certain annual documentation to DCFS and the House and Senate education committees to require that documentation be provided only when DCFS or the committees request it. Representative Smith offered a motion to adopt the proposed amendments, to which Representative Nancy Landry objected. The secretary called the roll, and the motion failed to pass by a vote of 1 yea and 12 nays. Representative Smith voted yea. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Simon, and Wright voted nay.

Representatives Bouie, Brass, Emerson, Hall, Hilferty, Simon, and Smith voted yea. Representatives Amedee, Edmonds, Falconer, and Wright voted nay. Representative Nancy Landry abstained.

Representative Ivey presented House Bill No. 418, which authorizes public postsecondary education management boards to increase tuition and provides for limitations and exceptions.

Representative Amedee offered a motion to report House Bill No. 418 favorably. Without objection, House Bill No. 418 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Smith, and Wright voted yea.

House Bill No. 487 by Representative Zeringue

Representative Zeringue presented House Bill No. 487, which creates a program for education savings accounts for tuition expenses for elementary and secondary schools.

Representative Falconer offered a motion to report House Bill No. 487 favorably, to which Representative Smith objected. The secretary called the roll, and House Bill No. 487 was reported favorably by a vote of 10 yeas and 2 nays. Representatives Nancy Landry, Amedee, Brass, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, and Wright voted yea. Representatives Bouie and Smith voted nay.
