III. DISCUSSION OF LEGISLATION

Senate Bill No. 264 by Senator Carter

Senator Carter presented Senate Bill No. 264, which requires public safety telecommunicators who provide dispatch for emergency medical conditions be trained in the delivery of telephone CPR.

Representative Cox offered amendments which:

- 1. Stipulate that certain training required by proposed law shall meet or exceed nationally recognized guidelines.
- 2. Provide that proposed law shall not apply to any parish with a population equal to or less than 100,000.
- 3. Provide that proposed law may be referred to as the Spencer Washington Act.
