III. DISCUSSION OF LEGISLATION

House Bill No. 235 by Representative Amedee

Representative Amedee presented House Bill No. 235, which provides relative to justifiable use of force or violence in defense at a place of worship.

On behalf of the author, Representative Bacala offered amendments to remove the requirement that the person may only claim a defense that involves the use of a firearm if the person lawfully possessed the firearm under state or federal law and add a requirement that the person may only claim a defense that involves the use of a firearm if the person was not prohibited from possessing a firearm under state or federal law. Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Crews, Duplessis, Howard, James, Marcelle, Marino, Moss, Muscarello, and Pylant voted yea.

motion, and the motion failed to pass by a vote of 7 yeas, 8 nays, and 1 abstention. Representatives Bacala, Crews, Dwight, Hodges, Howard, Muscarello, and Pylant voted yea. Representatives Bagneris, Carpenter, Duplessis, Gaines, James, Marcelle, Marino, and Norton voted nay. Representative Mack abstained.

The secretary called the roll on Representative Duplessis' original motion, and the motion failed to pass by a vote of 7 yeas, 8 nays, and 1 abstention. Representatives Carpenter, Duplessis, Gaines, James, Marcelle, Marino, and Norton voted yea. Representatives Bacala, Crews, Dwight, Hodges, Howard, Moss, Muscarello, and Pylant voted nay. Representative Mack abstained.

Representative Bacala offered a motion to report House Bill No. 281 favorably, to which Representative Duplessis objected. The secretary called the roll, and House Bill No. 281 was reported favorably by a vote of 8 yeas, 7 nays, and 1 abstention. Representatives Bacala, Crews, Dwight, Hodges, Howard, Moss, Muscarello, and Pylant voted yea. Representatives Carpenter, Duplessis, Gaines, James, Marcelle, Marino, and Norton voted nay. Representative Mack abstained.

House Bill No. 6 by Representative Jenkins

Representative Jenkins presented House Bill No. 6, which creates the crime of aggressive driving and provides for the elements and penalties of the offense.

On behalf of the author, Representative Mack offered amendments to amend the elements of the proposed law offense to refer to specific traffic violations provided in present law for a second or subsequent violation of proposed law, remove the requirement that the term of imprisonment be served with or without hard labor, provide that a conviction or plea of guilty for a violation of proposed law shall be included in the offender's operating record, and make technical corrections. Representative Mack offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Dwight, Gaines, Howard, Marcelle, Marino, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Jenkins provided a video presentation and a handout, Exhibit A, which is included in the committee records.

Representative James offered an amendment to add that any petitioner who has been awarded compensation and who has received a portion of such compensation prior to Aug. 1, 2019, may petition the court by Aug. 1, 2020, to seek the remainder of the compensation, not to exceed \$80,000, or be forever barred from filing such petition. Representative James offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Bacala, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, James, Marcelle, Marino, Moss, Muscarello, and Pylant voted yea. Representative Mack abstained.

Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, Howard, James, Marcelle, Marino, Moss, Muscarello, and Pylant voted yea. Representative Mack abstained.

Representative Marcelle offered a motion to report House Bill No. 65 with amendments, to which Representative Bacala objected. The secretary called the roll, and House Bill No. 65 was reported with amendments by a vote of 9 yeas and 6 nays. Representatives Carpenter, Duplessis, Gaines, Howard, James, Marcelle, Marino, Norton, and Pylant voted yea. Representatives Bacala, Crews, Dwight, Hodges, Moss, and Muscarello voted nay.

- (1) Add to the list of persons whose identity shall not be disclosed those persons who synthesize, prepare, test, use, sell, import, distribute, or administer any substance, medical supplies, or medical equipment utilized in the execution of a death sentence.
- (2) Add that the identity and information about the identity of persons protected under proposed law shall not be admissible or discoverable in any proceeding before any commission or any legislative or quasi-legislative body

Representative Mack offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Bacala,

Duplessis, Dwight, Gaines, Hodges, Howard, Moss, and Pylant voted yea. Representative Mack abstained.

House Bill No. 279 by Representative Marino

Representative Marino presented House Bill No. 279, which provides relative to the transfer of firearms of persons who are prohibited from possessing a firearm in domestic abuse cases.

Representative Marino offered amendments to:

- (1) Delete changes made to present law provisions regarding the prohibition on possession of a firearm by persons convicted of felony crimes of violence and certain domestic abuse related offenses.
- (2) Require the proof of transfer form to attest that the person is not currently in possession of firearms and is currently compliant with state and federal law, but prohibits the form from including the date on which the transfer occurred.
- (3) In cases of third-party transfers, extends the time period within which the proof of transfer form is to be executed, and the time period within which the form is to be filed with the clerk of court, from five days to ten days.
- (4) Add that the receipt for each firearm transferred prepared by the sheriff and the records of all firearms transferred kept by the sheriff shall not include the date that the firearms were transferred.
- (5) Authorize the person, not sooner than three years after the date on which the firearms are returned, to file a motion requesting that the records relative to the firearms held by the clerk of court and the sheriff be destroyed.
- (6) Make technical corrections.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Crews, Duplessis, Dwight, Hodges, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Marino offered an amendment to remove the authority of the committee on parole to revoke the parole of an offender who commits a fourth or subsequent technical violation and instead require the offender to serve a sentence of up to 90 days. Representative Marino offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Duplessis offered an amendment to delete the provision which requires the committee on parole to review the case of an offender who completes the intensive incarceration program provided for in present law and the committee's authority to recommend that the offender be released on intensive parole supervision, and make other technical amendments with regard to this change. Representative Duplessis offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, James, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Moss offered a motion to report House Bill No. 149 with amendments. Without objection, House Bill No. 149 was reported with amendments by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, James, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

(1) Change proposed law references of "hemp" to "industrial hemp".

- (2) Provide that the present law definition of "marijuana" does not apply to industrial hemp that is in the possession, custody, or control of a person who holds a license issued by the Louisiana Department of Agriculture and Forestry, or is cultivated and processed in accordance with the U.S. Agriculture Improvement Act of 2018.
- (3) Amend the proposed law definition of "industrial hemp" to include that it is cultivated and processed in accordance with the U.S. Agriculture Improvement Act of 2018, or the plan submitted by the Louisiana Department of Agriculture and Forestry.
- (4) Prohibit any person from cultivating, possessing, or selling industrial hemp, industrial hemp products, or viable industrial hemp seeds not in accordance with the U.S. Agriculture Improvement Act of 2018 or the plan submitted by the Louisiana Department of Agriculture and Forestry.

Representative James offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, James, Marino, Muscarello, and Norton voted yea. Representative Mack abstained.

Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Bacala, Crews, Duplessis, Dwight, Hodges, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Hilferty presented House Bill No. 185, which provides relative to the registration of persons convicted of terrorism offenses and offenses against peace officers.

Representative Moss offered a motion to report House Bill No. 139 with amendments. Without objection, House Bill No. 139 was reported with amendments by a vote of 11 yeas, 0 nays, and 1

abstention. Representatives Bacala, Carpenter, Crews, Duplessis, Dwight, Hodges, James, Marino, Moss, Muscarello, and Pylant voted yea. Representative Mack abstained.
