# Senate Bill No. 1 by Senator Peacock

Senator Peacock presented Senate Bill No. 1, which provides for the investment of funds by the board of trustees for the Bossier City Police Pension and Relief Fund.

Representative Ivey offered a motion to report Senate Bill No. 1 favorably. Without objection, Senate Bill No. 1 was reported favorably by a vote of 6 yeas and 0 nays. Representatives Pearson, LaCombe, Moore, Abraham, Bacala, and Ivey voted yea.

Without objection, the amendments were adopted by a vote of 7 yeas and 0 nays. Representatives Pearson, LaCombe, Moore, Abraham, Bacala, Ivey, and Jones voted yea.
