Representative Miguez presented House Bill No. 781, which provides relative to the authority to regulate the manufacture, possession, or sale of firearms or ammunition during a declared emergency or disaster or public health emergency.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Add that the governor's and parish president's authority to commandeer or utilize private property during a declared disaster or emergency or public health emergency does not apply to firearms, ammunition, or components of firearms or ammunition;

- (2) With regard to declared public health emergencies, remove the governor's authority to suspend or limit the sale, dispensing, or transportation of firearms and provide that the governor's authority to suspend or limit the sale, dispensing, or transportation of explosives and combustibles does not apply to components of firearms ammunition; and
- (3) Provide that present law provisions prohibiting the seizure of lawfully possessed firearms or ammunition during a declared emergency or disaster shall apply also to declared public health emergencies.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

- (2) Move proposed law provisions relative to the proposition election on sports wagering to Title 18 rather than Title 27 of the La. Revised Statutes of 1950;
- (3) Relative to the regulatory authority of the La. Gaming Control Board, require the board to have all regulatory authority, control, and jurisdiction and all power incidental or necessary to such regulatory authority, control, and jurisdiction over all aspects of sports wagering activities and operations;
- (4) Provide for a definition of "sports wagering"; and
- (5) Modify the effective date to certain provisions of proposed law.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Nelson, and Villio voted yea.

- (2) Remove the present law provision which authorizes the court to deny a motion to modify without a contradictory hearing;
- (3) Provide that any motion for modification shall be tried contradictorily against the district attorney; and
- (4) Restore the present law provision which requires the court to conduct a contradictory hearing when the motion to modify seeks the imposition of more restrictive conditions, except upon the waiver of the parties.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bacala, Bryant, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

 - (b) Specify that the information in the letter regarding the location of incarceration shall include only the information about the last location of incarceration.
 - (c) Remove the requirement that the letter include information regarding the offense or offenses for which the person was confined; and
- (4) Remove the proposed law provision which allows the person to request that the letter include information regarding the person's conviction history and security status or classification status at the time of release.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.
