III. DISCUSSION OF LEGISLATION

House Bill No. 862 by Representative Garofalo

Chairwoman Davis announced that action on House Bill No. 862, which provides for the COVID-19 Business Recovery and Growth Program, was voluntarily deferred.

House Bill No. 763 by Representative McFarland

Representative McFarland presented House Bill No. 763, which provides relative to a gubernatorial declaration of an abnormal economic disruption.

Representative Thomas offered a motion to report House Bill No. 763 favorably. Without objection, House Bill No. 763 was reported favorably by a vote of 14 yeas and 0 nays. Representatives Davis, Hilferty, Duplessis, Fontenot, Goudeau, Green, Henry, Jordan, McCormick, McKnight, St. Blanc, Tarver, Thomas, and Villio voted yea.

House Bill No. 722 by Representative Gregory Miller

Representative Gregory Miller presented House Bill No. 722, which provides for the enforcement of electronic signatures by financial institutions.

Representative Jordan offered amendments to House Bill No. 284 which would: (1) narrow the definition of "branch" or "branch office" in present law to clarify that it does not include a loan production office, deposit production office, or a combined office; (2) add the requirement that a loan production office, deposit production office, or a combined office be physically-manned; (3) allow a financial institution which is opening a combined loan production office and deposit production office to satisfy the notice required by proposed law by submitting one combined written notice to the commissioner; and (4) make technical changes.

Representative Jordan offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Davis, Hilferty, Duplessis, Fontenot, Goudeau, Green, Henry, Jordan, McCormick, McKnight, St. Blanc, Tarver, Thomas, and Villio voted yea.

Representative Villio offered a motion to report House Bill No. 284 with amendments. Without objection, House Bill No. 284 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Davis, Hilferty, Duplessis, Fontenot, Goudeau, Green, Henry, Jordan, McCormick, McKnight, St. Blanc, Tarver, Thomas, and Villio voted yea.
