III. DISCUSSION OF LEGISLATION**House Resolution No. 46 by Representative Bagley**

Representative Bagley presented House Resolution No. 46, which authorizes and directs the executive branch agencies that submit statutorily required reports to the House Committee on Health and Welfare to continue to submit such reports as required by law.

Representative Cox offered amendments which make technical changes. Representative Cox offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Travis Johnson, Larvadain, McMahan, Moore, Pressly, Selders, and Stagni voted yea.

Representative Cox offered a motion to report House Resolution No. 46 with amendments. Without objection, House Resolution No. 46 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Travis Johnson, Larvadain, McMahan, Moore, Pressly, Selders, and Stagni voted yea.

House Resolution No. 47 by Representative Deshotel
