House Resolution No. 46 by Representative Bagley

Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Travis Johnson, Larvadain, McMahen, Moore, Pressly, Selders, and Stagni voted yea.

Representative Cox offered a motion to report House Resolution No. 46 with amendments. Without objection, House Resolution No. 46 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Travis Johnson, Larvadain, McMahen, Moore, Pressly, Selders, and Stagni voted yea.
