House Concurrent Resolution No. 11 by Representative Fontenot

Representative Fontenot presented House Concurrent Resolution No. 11, which memorializes the U.S. Congress and the Louisiana congressional delegation to remove the revenue sharing cap on the Gulf of Mexico Energy Securities Act of 2006 for Gulf producing states and to take such actions as are necessary to rectify the federal revenue sharing inequities between energy producing states.

Representative Kerner offered a motion to report House Concurrent Resolution No. 11 favorably. Without objection, House Concurrent Resolution No. 11 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Coussan, Bourriaque, Butler, Carrier, Deshotel, Kerner, Mincey, Romero, and Wheat voted yea.
