III. DISCUSSION OF LEGISLATION

Representative Stefanski in the chair

House Concurrent Resolution No. 87 by Representative Magee

Representative Magee presented House Concurrent Resolution No. 87, which urges and requests that any proclamation convening an extraordinary session of the legislature in 2020 include an extension of effectiveness and changes to eligibility requirements of the rehabilitation of historic structures tax credit.

Representative Stefanski offered a motion to report House Concurrent Resolution No. 87 favorably. Without objection, House Concurrent Resolution No. 87 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 138 by Senator Allain

Senator Allain presented Senate Bill No. 138, which provides for sales and use tax collection by marketplace facilitators.

Mr. Luke Morris, assistant secretary, Louisiana Department of Revenue, 617 North 3rd Street, Baton Rouge, LA 70802, (225) 219-2153, presented an overview of Louisiana legislative history on remote sellers, Exhibit A, "Louisiana Department of Revenue, Senate Bill 138 Marketplace Facilitator & Remote Seller Legislation", which is included in the committee records. Mr. Morris spoke for information only on Senate Bill No. 138.

Representative Riser offered amendments which exclude "service suppliers" as defined in R.S. 33:9125(6)(b) from the definition of marketplace seller. Representative Riser offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Representative Mincey offered a motion to report Senate Bill No. 138 with amendments. Without objection, Senate Bill No. 138 was reported with amendments by a vote of 11 years and 0 nays.

Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 164 by Senator Allain

Senator Allain presented Senate Bill No. 164, which provides relative to local sales and use tax adjudication.

Representative Riser offered a motion to report Senate Bill No. 164 favorably. Without objection, Senate Bill No. 164 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 205 by Senator Allain

Senator Allain presented Senate Bill No. 205, which defines the term final determination for purposes of reporting federal income tax adjustments.

Representative Riser offered a motion to report Senate Bill No. 205 favorably. Without objection, Senate Bill No. 205 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, Ivey, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 283 by Senator Allain

Senator Allain presented Senate Bill No. 283, which provides relative to local sales tax administration.

Representative Mincey offered a motion to report Senate Bill No. 283 favorably. Without objection, Senate Bill No. 283 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, Ivey, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 498 by Senator Allain

Senator Allain presented Senate Bill No. 498, which provides for tax filing and payment extensions.

Secretary Kimberly Robinson, Louisiana Department of Revenue, P.O. Box 66258, Baton Rouge, LA 70896, (225) 219-4059, spoke for information only on Senate Bill No. 498.

Representative Riser offered a motion to report Senate Bill No. 498 favorably. Without objection, Senate Bill No. 498 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Bryant, Butler, Farnum, Hughes, Ivey, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 487 by Senator Allain

Senator Allain presented Senate Bill No. 487, which provides relative to the capital outlay application process.

Representative Riser offered a motion to report Senate Bill No. 487 favorably. Without objection, Senate Bill No. 487 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Bryant, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Senate Bill No. 33 by Senator Hensgens

On behalf of Senator Hensgens, Senator Allain presented Senate Bill No. 33, which re-creates the income tax checkoff donation for Dreams Come True, Inc.

Representative Bourriaque offered a motion to report Senate Bill No. 33 favorably. Without objection, Senate Bill No. 33 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bourriaque, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

House Bill No. 561 by Representative Dwight

On behalf of Representative Dwight, Mr. Cade Cole, Louisiana Board of Tax Appeals, 627 North 4th Street, Baton Rouge, LA 70802, (225) 922-0172, presented House Bill No. 561, which provides

for the administration, enforcement, and adjudication of state and local taxes and for the jurisdiction of the Board of Tax Appeals.

Representative Stefanski offered amendments which: (1) authorize a collector to extend filing or payment deadlines for the payment of local taxes until the extended date for the payment of state sales and use taxes in the event of a presidential of gubernatorial declared disaster or emergency covering a local collector's jurisdiction; (2) prohibit interest and penalties from accruing on the tax during the period of the extension provided the return and payment are received by the extended due date; (3) require decisions adopting an extension of the filing or payment deadline to be published on the Louisiana Uniform Local Sales Tax Board's website; (4) extend eligibility for the waiver of penalties if the taxpayer establishes that the failure to file a return during presidential or gubernatorial declared disaster or emergency was due to the inaccessibility of funds to pay the tax, the unavailability of records or personnel to prepare and file the return, or confusion over the extension of related state sales and use tax filing deadlines; and (5) authorize the Louisiana Uniform Local Sales Tax Board to file an action for uniformity in the same manner as a local collector.

Representative Stefanski offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bryant, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.

Representative Farnum offered a motion to report House Bill No. 561 with amendments. Without objection, House Bill No. 561 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Beaullieu, Bryant, Butler, Farnum, Hughes, LaCombe, McMahen, Mincey, Riser, Stefanski, and Willard voted yea.
